3. Summary of Proceedings

Welcome remarks

The Chairperson opened the meeting and welcomed all.

Opening Prayer

The meeting was opened with a word of prayer by Mr. Innocent Mabongo.

Introductions and Objectives of the Meeting

The Chairperson apologised for the late meeting invitation and requested participants to introduce themselves through the virtual meeting chat-box. The Chairperson outlined the objective of the meeting as seeking endorsement for the following:

- i. Justice Portfolio Document (2022-2026), including the Justice Project (2022-2026) and the Annual Work Plan (AWP) 2022;
- ii. Portfolio Steering Committee (PSC) Nominations; and
- iii. Monthly Justice Technical Working Group (TWG) meetings.

Presentation of the Justice Portfolio Document

UNDP Programme Specialist - Justice, Natasha Hirschfeld, presented the portfolio document (see PowerPoint Presentation attached).

Q&A

The Chairperson opened the floor for endorsement of the Justice Portfolio document including the AWP 2022, PSC nominations and monthly Justice TWG meetings. Endorsements were received from representatives of Administration of Justice (AoJ), Legal Aid Botswana, Botswana Centre for Public Integrity (BCPI), Directorate on Corruption and Economic Crime (DCEC) and Botswana Network on Ethics, Law and HIV/AIDS (BONELA).

The rest of the meeting followed suit and agreed in concert. In essence, there were no objections to endorsement of any of the meeting objectives.

Way Forward

The Co-Chair reiterated that the LPAC had officially endorsed the Justice Portfolio document—including the Justice Project 2022-2026 and AWP 2022, Justice PSC nominations, and monthly Justice TWG meetings. The Co-Chairperson noted that the Minutes of the LPAC Meeting were to be signed by 19 May 2022. Further, the Co-Chairperson informed the meeting that the PSC nominees were expected to attend the apex PSC meeting scheduled for 20 May 2022 in Gaborone, where it was anticipated

that the Justice Portfolio document will be endorsed and signed by the apex PSC on the same day.

Conclusion

In concluding remarks, the Chairperson underscored her appreciation for the support from UNDP and noted that, as Implementing Partners (IPs), they saw the proposed initiatives as opportunities to tremendously transform the landscape of Botswana towards a "#AJustBotswana# / AJustBW / #AJB-SDG16" and urged commitment from IPs to the endorsed documents and substantive activities.

The meeting was closed with a word of prayer by Mr. Innocent Mabongo.
