

AMENDMENT TO THE CONTRACT

BETWEEN

UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP)

AND

JOINT UNITED NATIONS PROGRAMME ON HIV/AIDS (UNAIDS)

Reference is made to the Annex to Cost Sharing Agreement (hereinafter "Agreement") dated on **31ST July 2013** signed between the UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP), and the JOINT UNITED NATIONS PROGRAMME ON HIV/AIDS (UNAIDS), with respect to the Project "*Appui institutionnel pour le renforcement des capacités de planification, coordination et de suivi-évaluation des actions de lutte contre la pauvreté au niveau national et des collectivités territoriales*" and as per **Article H of the Agreement**, any modification to this Agreement shall be made in writing between both parties and duly signed by the authorized representatives of the UNAIDS and UNDP.

Therefore Parties hereby agree on the following;

WHEREAS the UNAIDS and UNDP now wish to amend the said Agreement in order to extend the duration of the completion of the activities;

WHEREAS such Amendment will not impact the amount of the Agreement;

NOW THEREFORE, the relevant Agreement provisions indicated below are hereby amended to read as follows:

ARTICLE A. SUMMARY OF ACTIVITIES

Start/End Dates: 20 August 2013 (Transfer of Funds)
 30 June 2014 (date of completion of activities)

ARTICLE E. CONTRIBUTIONS

The total amounts paid by the Contributing Agency shall match the total budget amount. For Activities less than one year in duration the Contribution will be paid to the Recipient Agency prior to the commencement of Activities. For multi-year Activities the Contribution will be paid in installments according to the following schedule.

The schedule of payment:

30 – September 2013	FCFA 6 250 000
30 April 2014	F.CFA 6 250 000

NEVERTHELESS, all other terms and conditions of the Agreement, except as amended herein, shall remain unchanged and shall continue in full force and effect.

The amendment will enter into effect upon signature by both parties. Please find two signed originals letters of amendment. Please sign both originals, retain one original and return one to us for our filing.
