Dear beneficiaries and partners,

All projects start, are implemented and come to an end.

The Project to Strengthen Functional and Technical Capacities of Supreme Audit Institutions, National Parliaments and Civil Society for the control of Public Finances in the PALOP and Timor-Leste, the Pro PALOP-TL SAI, is now closed, and so much has been accomplished, that it is difficult to refer to all the progress achieved in a closure note.
