QUESTION 1: How Does the Project Integrate the Overarching Principles in order to Strengthen Social and Environmental Sustainability?

Briefly describe in the space below how the Project mainstreams the human-rights based approach

The overall objective of the project is to close a painful chapter in the history of the island and contribute to the process of rapprochement and reconciliation between the Greek Cypriot and Turkish Cypriot communities.

This process is carried out by a bi-communal team of Cypriot scientists and has resulted in international recognition of the CMP as an example of cooperation between the two Cypriot communities. As such, the CMP contributes towards the strengthening of a positive momentum in the continuing efforts for rapprochement and reconciliation between the Greek Cypriot and Turkish Cypriot communities.

The CMP believes that addressing the issue of missing persons in Cyprus and recovering their remains is both imperative, for reconciliation purposes, and urgent, in view of the amount of time that has already passed since the tragic events took place. Utmost attention must be given to the needs of the families of the missing, to enable both communities to move forward with greater serenity. Establishing the fate of their loved ones and, where possible, recovering their remains, is a crucial part of the healing process, not only for the relatives of the victims themselves, but for the Cypriot society in general.

Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment

The project will contribute to the gender equality and women’s empowerment by having majority of personnel as women, including as coordinators are project coordination level.

In line with EU and United Nations gender mainstreaming policies, UNDP will encourage CMP to promote full participation of women in all phases of the projects as personnel, including anthropologists, archaeologists, researchers/investigators, geneticists, workers, coordinators, managers or decision-makers. Attention will be given to ensure that, to the extent possible, CMP teams are gender responsive and that gender balance is addressed in their own structures, decision-making processes and selection processes.

The vast majority of those who suffered from the disappearances of their loved ones in Cyprus were and are women who survived their missing husbands and sons. This project contributes to women empowerment and gender equality by addressing the need of these family members to know the fate of their loved ones and contribute to their healing process.



