Brief description: This project covers the secretariat of the Operational Unit for Development assistance (established by the Prime Minister Decree no 1752 issued in the year 2003) and completes the UNDP assistance provided since the establishment of OUDA, towards its functional, institutional and financial sustainability.

Part Ia. Situation Analysis

The national execution modality was introduced by UNDP General Council decisions 90/21,91/27 and 92/22 with a view to enhancing self-reliance and national ownership of development assistance programmes. The Operational unit for Development Assistance (OUDA) was created in Egypt in 1992 as a UNDP project (EGY/92/015) nationally executed by the Ministry of Foreign Affairs. The OUDA project was in 1992 considered an innovative approach to encourage the national execution modality and assist the national entities that did not have the capacity to implement the UNDP national executed projects. It was established to initially overcome difficulties and constraints and to provide administrative support services to the project management in a manner that adheres to the UNDP policies. The OUDA staff were trained and national capacity was built within OUDA to deal with the implementation of the development projects and assist in the delivery of projects. encouraged to become a semi autonomous entity and financially self-sufficient. As such OUDA generated its own resources through training activities and its training centers, together with the fees they started to collect from the UNDP projects implemented by them. In January 2001 a new phase of the OUDA project was signed (EGY/00/012) for three years on the understanding that a mechanism will be reached and established within the legal framework of UNDP to include all OUDA activities (UNDP and non UNDP activities). mission also took place in April 2002 to look into the status of the OUDA project. The mission confirmed that OUDA cannot continue the non-UNDP activities unless it has a legal status or as a last alternative channel all the non UNDP activities through UNDP as cost sharing. In October 2003 a Prime Minister decree no 1752 was issued establishing OUDA as a unit within the Ministry of Foreign Affairs, under the supervision of the Minister of State for Foreign Affairs. The legal status ensures clear accountability for OUDA activities for both UNDP and non UNDP projects. The unit as such is able to assist the Ministry by providing on demand implementation support for development projects.

Part Ib. Strategy

With the issuance of the Prime Minister's decree and establishment of OUDA as a unit within the Ministry of Foreign Affairs, under the supervision of the Minister of State for Foreign Affairs, it was envisaged/agreed that the OUDA secretariat would still require (at least at this early stage) the support of UNDP to assist it in reaching its objectives. This UNDP project will allow OUDA to smoothly continue providing services to the national executing agencies and UNDP projects. It has also been agreed that the project document titled "Project Implementation services by OUDA" will also be signed. This second project will cover the support that OUDA provides to the various Ministries in the implementation of capacity building projects funded by bilateral donors that fall within the mandate of UNDP. The OUDA with its new legal status and capacity as a unit within the Ministry of Foreign Affairs may also manage projects outside

a UNDP framework, in which case the administrative and financial rules and regulations of the donor will prevail. The bank accounts for such activities/dealings will be opened, handled and audited by the Ministry of Foreign Affairs, International Co-operation Sector.

Part II. Results Framework

This project aims at consolidating OUDA independent operational and capacity in providing support services to UNDP projects upon request and to provide support services to the activities that fall within the umbrella project. It will, therefore, support OUDA in the transition to its newly organized legal status towards full self-reliance.

Part III. Management Arrangements

The Ministry of Foreign Affairs, International Co-operation Sector, is the executing agency for this project which will be executed under the UNDP national execution modality. A project director will be selected and contracted in accordance with the UNDP guidelines. The UNDP project will open a bank account for this project, separate from the bank accounts to be opened for the umbrella project and the UNDP projects eventually assisted by OUDA. The project will be subject to an annual review, audit and an evaluation two years after signature conducted together with the OUDA umbrella project. The Project will deliver an annual work plan and OUDA will work with UNDP according to the new global software system (ERP) that has been implemented in January 2004.

This project document shall be the instrument referred to as such in Article 1 of the Standard Basic Assistance Agreement between the Government of Egypt and the United Nations Development Programme signed by the parties on 19 January 1987.
