## Joint Programme on Data for Development (EPHS) - AWP 2015

**National Priority:** Strengthening capacity to plan, monitor and evaluate programmes at national, regional and local levels

**SPCF Outcome 4:** Selected government institutions have the capacity to effectively and efficiently deliver services to all. This outcome will focus on human resource development and institutional strengthening of relevant public institutions. Support will also be given to human resource development in the higher education sector.

**Expected Output:** By 2016, Capacity improved for the generation of gender disaggregated data on various development indicators including population dynamics, and systems strengthened within NSO, sector ministries and regions for effective development planning and management.

**Government Coordinating Authority:** Ministry of National Development (MoND)

**Implementing partner:** Ministry of National Development/National Statistics Office (MoND/NSO)

**Other partners:** Ministry of Health (MoH), Ministry of Local Government (MoLG) and other concerned Ministries and Zoba administrations, as required.

### Executive Summary

This 2015 Annual Work Plan (AWP) is prepared to support the preparation of the fourth round Eritrean Population and Health Survey (EPHS 2015). Since conducting EPHS is an event rather than a programme, it is necessary to prepare a separate AWP which is independent of the ongoing JP on Data for Development which involves UNFPA, UNDP and UNICEF.

The activities that are expected to be implemented under this Annual work Plan are related to the Pre-enumeration phase. The population and health survey is expected to include various components like HIV, Hepatitis B, and Hepatitis C, as well as Micronutrient survey in addition to the traditional indicators.

The MoND/NSO will be responsible for the implementation of the 2015 AWP, thereby closely liaising with relevant ministries and UNFPA as the Managing Agent (MA) on Data for Development (D4D). The MA is accountable for providing the required support to the implementing partner in managing all components of the JP and will provide periodic reports to participating agencies. Pooled funding modality will be followed in support of the activities envisaged in this AWP. However, when the need arises to carryout particular activities such as international procurement, participating UN Organizations could do so through their respective Procurement Services.


