# LETTER OF AGREEMENT BETWEEN UNDP AND Network of Networks of HIV Positives in Ethiopia (NEP+)

FOR THE Implementation of the HIV/Aids related Stigma Index Study

This Letter of Agreement (hereinafter referred to as the "Agreement") is made between the United Nations Development Programme (hereinafter referred to as "UNDP") and the Network of Networks of HIV Positives in Ethiopia (NEP+) (hereinafter referred to as "Responsible Party").

### Responsibilities of the RESPONSIBLE PARTY I.

- The RESPONSIBLE PARTY agrees to: 1) Undertake the activities described in its Workplan (Annex 1) and Budget (Annex 2) (attached), and updates related to the subsequent release of funds in lump sum manner; 2) Provide quarterly reports to UNDP as per the Workplan Monitoring Tool (Annex 3); and 3) Provide Annual Audited Statements [Income Statement and Balance Sheets]. Funds provided pursuant to this Agreement shall be used for purposes related to producing results specified in the Workplan and in accordance with Article 3.3.
- The RESPONSIBLE PARTY agrees to reach the performance targets contained in the Work Plan. If the RESPONSIBLE PARTY fails to meet its responsibilities outlined in article 1.1, or to attain at least 70% of any one performance target for any given year, then this will be considered grounds for the Core Group to suggest for the return of the funds. The retuned funds shall remain with UNDP until the RESPONSIBLE PARTY has achieved the target.
- The RESPONSIBLE PARTY agrees to inform UNDP of any problems it may face in attaining 1.3 the objectives agreed upon.

### II. Duration

This Agreement will come into effect on 1st November 2009 and shall expire on 30th September 2010, covering the anticipated term of the project. It can be extended, if necessary by exchange of letters, noting the new expiration date.

### III. **Payments**

UNDP shall provide funds to the RESPONSIBLE PARTY an amount of USD 88,445.00 (Eighty Eight Thousand and Four Hundred Forty Five US Dollars) equivalent to local currency to partially cover the project costs as indicated in the budget. Payment shall be made upon signature of this Agreement.
