AMENDMENT TO THE AGREEMENT

BETWEEN

THE MINISTRY FOR FOREIGN AFFAIRS OF THE REPUBLIC OF FINLAND (DONOR)

AND THE UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP)

Reference is made to the Agreement (hereinafter the "Agreement") dated 7 April 2012 signed between the United Nations Development Programme (hereinafter "UNDP"), and the Ministry for Foreign Affairs of the Republic of Finland (hereinafter the "Donor" and together with UNDP, the "Parties") with respect to the UNDP Thematic Trust Fund for Gender established by the Administrator the year in 2001, and as per Article 7 of the Agreement between the Donor and UNDP regarding Contribution to the Thematic Trust Fund for Gender (hereinafter the "Agreement"), any modification to this Agreement shall be made in writing between both parties and duly signed by the authorized representatives of the Donor and UNDP.

Therefore Parties hereby agree on the following;

WHEREAS the donor and UNDP now wish to amend the said Agreement through the present amendment (the "Amendment") in order to increase the value of the Contribution (as defined in the Agreement);

WHEREAS such Amendment will result in an increase of EUROS 2,600,000 (EUROS Two Million Six Hundred Thousand);

NOW THEREFORE, the relevant Agreement provisions indicated below are hereby amended to read as follows:

Article 3 of the Agreement shall be complemented as follows: "3 (c) The Donor shall, in accordance with the below schedule of payments set out below, and subject to annual parliamentary approval in Finland, contribute to UNDP the amount of EUROS 2.6 million in the bank account stated in the Agreement to implement activities in accordance with the attached new version of the Annex 2 (Global Gender Responsive Climate Change Programme, Proposal for the Fourth Phase of GGCCA Activities) that replaces the previous Annex 2 (Gender Responsive Climate Change Initiatives and Decision-making, Proposal for Third Phase of GGCA Activities, 2012-2014)."

Schedule of Payments and Amount:

1. Upon signature of the present Amendment: €1,300,000 (Euros One Million Three Hundred Thousand)
2. Upon submission of yearly report 2014: €1,300,000 (Euros One Million Three Hundred Thousand)

Article 4 of the Agreement shall be replaced as follows: "In accordance with the decisions and directives of UNDP's Executive Board reflected in its Policy on Cost Recovery from Other Resources, the

Contribution shall be subject to cost recovery for indirect costs incurred by UNDP headquarters and country office structures in providing General Management Support (GMS) services. To cover these GMS costs, the contribution shall be charged a fee equal to 8% (eight per cent). Furthermore, as long as they are unequivocally linked to the specific project(s), all direct costs of implementation, including the costs of executing entity or implementing partner, will be identified in the project budget against a relevant budget line and borne by the project accordingly."

NEVERTHELESS, all other terms and conditions of the Agreement, except as amended herein, shall remain unchanged and shall continue in full force and effect.

The Amendment will enter into effect upon signature by both parties and deposit of the additional contribution. Please find two signed originals letters of Amendment. Please sign both originals, retain one original and return one to us for our filing.
