Furthermore, ARECA, has 11 projects which has been guaranteed credit in the regional banking for a total amount of US\$3,287,360.00. Currently, ARECA has in the CABEI's process of approval two (2) partial credit guarantees for a total of US\$1,690,000.00, also are in the process of analysis two (2) guarantees US\$1,725,000.00. All of these guarantees are of the Guatemala Republic.

During this quarter, ARECA has approved Technical Assistance for an amount of US\$153,250.00, and on a cumulative basis a total of US\$906,235, and the same time disbursed at December 31, 2015, a total amount of US\$403,658.95. Actually, are in the process of analyzing eight (8) Technical Assistance for a total amount of US\$620,000.00, which will be submitted for approval in the first quarter of 2016.
