### Memorandum of Understanding Between

### The Department for International Development (DFID), United Kingdom of Great Britain and Northern Izeland

And

The United Nations Resident Coordinator (UNRC) System, India regarding the Support to UNAIDS India Strategic Plan for the year 2007-2012

- 1. I am pleased to inform you that the Government of the United Kingdom of Great Britain and Northern Ireland acting through the Department for International Development ("DFID"), will make available to United Nations Resident Coordinator (UNRC) System a sum not exceeding £2,000,000 (two million pounds sterling), (referred to as "the Contribution") to support the Joint UN Response to HIV and AIDS in India, within the UNDAF framework, and the coordination and monitoring of this response.
- Within the UN Resident Coordinator system, the UNAIDS Country Coordinator (UCC), under the supervision of the UN Theme Group on HIV and AIDS will provide leadership for and coordinate the UN response in support of a scaled-up national response to HIV and AIDS.
- The Support will commence on 1<sup>st</sup> November 2007 and will end on 31 May 2012.
- 4. The arrangements for this Support and the purpose for which the Contribution will be used are set out in the attached proposal / work plan and budget.
- The Contribution will be administered by UNDP as Fund Manager and will be subject to the following conditions:

- (a) Disbursement of the funds will be performed by UNDP and the UNAIDS Country Coordinator will be the initiator of all requisitions. Funds will be used for the implementation of the Joint UN Support Plan approved by the UN Theme Group. UNAIDS Secretariat will make every effort to ensure timely and full implementation of the Workplan.
- (b) The Contribution will be used for the provision of goods and services as specified in the attached document.
- (c) The Contribution is stated in pounds sterling.
- (d) The contribution will not be used to meet the cost of import or customs duties (or any similar fees) imposed by the Government of India on the goods imported or services provided.
- 6. As soon as this Memorandum of Understanding comes into operation, DFiD will make payments in accordance with the following payment schedule:

£ 300,000	by	April 09- Sept 09

£ 300,000	by	April 11- Sept 11
£ 40,000	by	Oct 11 - May 12

- The total cost of administration and any other expense incurred by UNDP directly related to the support will not exceed 5%.
- 8. The payment schedule may be amended with DFID's approval dependant on

actual expenditure and need. DFID will notify UNDP and the UNAIDS Secretariat of each payment using Annex 1.

- 9. When requesting payment, the UNRC will submit to DFID a narrative report and financial statement, and complete Annex 2 which should be accompanied by a detailed breakdown of the following period's estimated cost. Further monitoring and reporting arrangements are specified in the attached proposal ("A proposal to DFID to support the Joint UN Response").

12. UNDP will ensure that the Contribution is, prior to disbursement, kept in an account where it may be separately accounted for. The funds in the Account may be freely exchanged by UNDP into other currencies as may facilitate their disbursement.

13. Any interest accrued from the investment of the Contribution will be used solely to fund activities related to this specific project.

14. At the end of the support, any unspent funds and/or interest accrued must be returned to the DFID bank account. UNDP should forward a completed Annex 3 to the DFID Programme Manager quoting the name of the Project and UNDP Project reference.

16. UNDP will administer and account for the Contribution in accordance with its financial regulations and other applicable rules and procedures and practices and keep separate records and accounts for the Project. The Contribution will be solely for the Joint UN Support Plan for HIV and AIDS for the period 2007 -2012.

17. Every six months, the UNRC will submit financial statements of expenditure to DFID. In addition, the UNRC will submit to DFID, within 3 months of completion of the Project, a final report, detailing the project expenditure and physical achievements.

18. UNDP will submit to DFID each year an annual financial statement certified as of 31 December by a recognised audit body, no later than 30 June of the following year.

19. It is the intention of DFID to establish a new Trust Fund for disbursement to the United Nations system, through the Resident Coordinator system, in support of the UNDAF 2008-2012. The current MOU will be subsumed within this broader Trust Fund framework, once established, without materially changing the terms of the MOU.

- 20. If any changes occur which, in the opinion of DFID, impair significantly the developmental value of the support; DFID, and the UNRC will normally consult on measures to resolve the problem and possible courses of action. In the event of such changes, DFID, however, reserves the right to modify or terminate its financial contribution to the project giving 3 months notice in writing. All remaining funds other than those irrevocably committed in good faith before the date of termination and those agreed between the two participants as being required to finalise activities will be returned to the DFID bank account detailed at paragraph 14. The form at Annex 3 should be sent to DFID.
- 21. DFID will not be responsible for the activities of any person or third party engaged by the UN as a result of this Memorandum, nor will DFID be liable for any costs incurred by the UN in terminating the engagement of any such person.
- 22. The MOU will come into operation on the date of signatures. Please sign three copies of the original, retain one each for your own records and return the other to DFID.

Memorandum of Understanding Between, The Department for International Development (DFID), United Kingdom of Great Britain and Northern Ireland and The United Nations Resident Coordinator (UNRC) System India regarding the Support to UNAIDS India Strategic Plan for the year 2007-2012 – Amendment 1
