Brief Description


UNDP has been cooperating with the Islamic Republic of Iran over the past 30 years. Its current programme cycle (2005-2011) is coming to an end. During 2010 - 2011, UNCT and the government have identified 5 priority areas of Poverty, Environment, Disaster Risk Management, Health and Drugs Control as per the 5th Five Year National Development Plan for the 2012-2016 United Nations Development Assistance Framework (UNDAF).

Early 2011, under the guidance of the Joint Country Programme Steering Committee (CP SC) the CO started its bilateral consultations with the government counterparts through the CP Working Groups. In June the 2012-2016 UNDP Country Programme Document was submitted for the Executive Board's review in September. The text of the CPD was endorsed by the EB with no further comments and is expected to be approved formally during January 2012 EB session.

The CO is in the process of finalizing the Country Programme Action Plan (CPAP) for which an Initiation Plan (Preparatory Assistance) is required to fulfil the advisory and support requirements of developing the CPAP. The PA project will continue for the duration to facilitate the start up of the new Country Programme.

I. PURPOSE

This is an Initiation Plan (Preparatory Assistance) for advisory and programme support during the CPAP preparation in 2011 as well as the start up of the new Country Programme in 2012. This process will require the recruitment of a number of consultant(s) for extracting UNDAF/Country programme baselines, formulating CPD related programmes, developing a comprehensive M&E framework for CPAP, identifying partnership and resource mobilization strategies, as well as proposing refined implementation arrangements. In addition, the PA project will facilitate series of workshops and other events to support the preparation of the new CPAP and programmes.

This Initiation Plan cannot be attributed to one programme cycle as it will use the foundation and lessons from 2005-2011 to prepare the programme for 2012-2016. As this Initiation Plan is only for consultancies advisory and support services to be implemented by UNDP, it will be set up as a Management Project in Atlas.

II. EXPECTED OUTPUT

The Initiation Plan is expected to provide the necessary technical support and input for the formulation of CPAP through the following consultancies in the following areas:

- Support the formulation of the Poverty Programme for 2012-2016
 - Input to CPAP and Poverty programme formulation through various forums
 - Consultancies required to develop the Poverty Programme document
 - Input for joint programming for poverty
 - Support in upscaling Carbon Sequestration
- Support the formulation of the Environment Programme for 2012-2016
 - Preparations of PIFs for accessing GEF projects
 - Identifying possible areas for UN joint programmes.
 - Input to CPAP and Environment programme formulation through various forums
- Support the formulation of the DRM Programme for 2012-2016
 - Elaboration of the DRM Programme for 2012-2016.
 - The RC Advisor/UNDP DRM consultant to carry out consultations with national partners and finalize the DRM programme document.
 - Operationalization of the new DRM programme
 - Consultant to assist UNDP to lead the UNDAF DRM Thematic Group.
- Support CCM in preparing proposals to GFATM for I. R. Iran
- Enhance M&E
 - Contribution to determining the UNDAF baselines, and elaboration of CPAP M&E Framework on this basis.
 - Development of M&E applications and softwares to be used in the next cycle
 - Preparation for use of DevInfo as an interagency tool for the M&E
- Support to the formulation and implementation of the Country Programme Action Plan:
 - Two substantive editors/consultants to assist the CO in editing/consulting on the text of the narrative and the Results Framework.
 - Proposal to address the issues concerning Government Cost Sharing
 - Proposal of harmonized HR practices and templates (for projects) to elaborate the Implementation Arrangement for CPAP projects.
 - Analysis of successful UNCT/UNDP projects' experiences for defining joint programming and possible upscaling.
 - Consultancy for the mapping and analysis of Capacity Gaps
 - Consultancy to define South-South capacities, needs and steps required to use this modality in the formulation and implementation of project and programmes
