## I. EXECUTIVE SUMMARY

The HIV and the Law Project seeks to identify legal and policy gaps that facilitate discrimination against vulnerable populations and present a costed plan of action for legal reform. The plan will highlight aspects of Jamaican legislation and policy that should be changed in order to increase access to treatment and prevention services. Another important component of the project is assessing the existing structures that facilitate legal action in instances of discrimination and how they can be strengthened to adequately provide access to justice.

Implementation of the project began in July through the Governance unit of UNDP. As envisaged, the necessary human resources to facilitate the direct implementation of the project, the HIV Programme Officer was recruited, however this recruitment experienced delays and the post was not filled until November 2012. The first official activity under the project was an awareness raising event targeting High Court Judges and Resident Magistrates. The key goal was to ensure that participants were sensitised to the impact of outdated and discriminatory laws on HIV and other key issues which were raised within the scope of work of the Global Commission on HIV and the Law. The key note address was from the former Australian Supreme Court Justice, Mr Michael Kirby, a member of the Global Commission on HIV and the Law which published its report the week before the sensitisation event.

The project has also identified key responsible party for the implementation of the primary outputs the most significant being the National HIV/STI programme, Ministry of Health. The Ministry has not only endorsed the project but has committed to take the lead in convening national stakeholder consultations which will be a key part of the process. In addition other stakeholders including CSO's, government entities and other UN partners have also committed to supporting the project.

<p>The conceptualization of the project drew heavily on the objectives outlined by the National HIV strategic plan for 2012-2016 where a key objective is the removal of discriminatory legislation and policies that hinder access to treatment and opportunities for prevention. Progress in this key area lies under the responsibility of the Enabling Environment portfolio and though work has been done with developing anti-discriminatory legislation through the HIV workplace policies, little progress has been made in removing discriminatory laws and policies. Throughout the project the NHP will remain a critical partner providing technical support and guidance and for particular components of the project being the lead agency.</p>	
<p>It is the intention that once the legal review is complete and the costed plan of action for legislative reform presented, the NHP can use the plan as platform to lobby for action on legal reform in parliament. Various CSO's and other government agencies will also be able to focus on aspects of legal reform which supports their mandates in relation to HIV. There will also be a process put in place to develop a strategy for advocacy involving multiple stakeholders. Donors will also have the option of funding different aspects of legal reform in keeping with their mandates and funding opportunities.</p>	
<p>The second phase of the project will address strengthening the capacity of legal aid services to ensure that sufficient structures are in places to provide access to justice. It will also provide for the opportunity to create a national dialogue on legal reform issues to ensure that the general population grasps the importance of addressing discriminatory policies and practices as it relates to HIV.</p>


