Background

UNDP has a strong relationship with the Government of Kenya and is fully committed to further strengthening this partnership. UNDP Kenya country office and the Government of Kenya have been enjoying constructive relationship, and fruitful partnership in the advancement of the country's development agenda since the UN came into existence in Kenya. In pursuit of the promotion of national ownership, the project "Support to National Execution" initiated in 2002 has been put in place for the delivery of programmes and projects. The main objective of this project has always been to build the capacity of the Government of Kenya to absorb and utilise donor resources more effectively and efficiently. The projects enhanced the ownership of the programmes and contributed to capacity building, particularly with respect to the development of human resources. More importantly, it strived for greater coordination of development partners programmes and aligned them to government's development programmes. This new phase of the project therefore is aimed at continuing to deepen the national ownership of development programmes and to enhance the absorption capacity of the government through enhanced management of programmes. The programme will run for two years until the end of the current Country Program Action Plan in 2008. A Letter Of Agreement between UNDP and the Government of Kenya will be signed in order to formalize the basic points of the programme. The project will provide support services as stated in the Letter Of

Agreement mentioned above and annexed as Appendix I in this Project Initiation Document (PID). The impact foreseen is to improve the capacity of the Kenya Government to deliver nationally executed projects effectively.

Project Definition

Project Objectives

UNDP has a mandate to work with countries to address national development challenges. Through supporting the Government on implementation and developing national capacity, UNDP is contributing to its goal of building and sharing solutions to national needs and furthering the effort to achieve the Millennium Development Goals, to promote growth and reduce poverty.

Project Scope and Exclusions

The scope of the Project is to provide the requested support services stated in the Letter Of Agreement signed between UNDP and GOK. Overall, the expected impact will be improved capacity of the Country Office to service the GOK effectively and efficiently through the provision of support services for the implementation of all nationally executed projects under the GOK/UNDP Country Action Plan 2004-2008, under the programmatic areas articulated below. Each programmatic unit will be supported with staff with specific Terms Of Reference.

Project Deliverables

The UNDP country office will provide, as agreed in the Annual Workplan, the following support services for the smooth implementation of project activities:

- Provide high-level advisory services in the implementation of the Economic Recovery Strategy and the realization of MDGs contained in the Country programme Action Plan
