IV. KEY DISCUSSION POINTS AND ACTION

AGENDA ITEM 1: OPENING REMARKS

The meeting began with welcoming remarks from Ms. Sonali Dayaratne (UNDP), Ms. Johanna Palmberg (Embassy of Sweden), and remarks from H.E. Dr. Tin Ponlok (NCSD).

Ms. Sonali Dayaratne, UNDP, welcomed guests and thanked the Embassy of Sweden for providing funding support to the BESD project. Further thanked the Royal Government of Cambodia (RGC) and varying ministries for their leadership and collaboration. Reiterated the overall objective of the meeting to review updated progress, work plans and proposed budget revisions. Expressed anticipation for fruitful discussion amongst partners.

Ms. Johanna Palmberg, Embassy of Sweden, emphasized importance of the BESD project and its ability to bring together a vast range of partners and stakeholders. Highlighted the potential for the project and partners to assist in providing changes in order to achieve the 2030 Sustainable Development Goals. Expressed interest for an engaging discussion and ways to jointly move forward on project implementation.

H.E. Dr. Tin Ponlok, NCSD, reiterated the importance of the project in achieving the 2030 SDGs. He highlighted that in this mandate the RGC puts priority on human development and innovation, response to climate change and environment sustainability in the government's Rectangular Strategy Phase 4. He expressed that the immediate outputs of the project are less important than the strategies and models that will be developed over the duration of the project which have potential to be replicated or scaled up by RGC.

AGENDA ITEM 2: PRESENTATION

The second Project Board Meeting was chaired by H.E. Dr. Tin Ponlok)NCSD).

Mr. Oum Sony, Policy Specialist, UNDP, gave a presentation which covered:

- 1. Brief introduction on project components (Natural Resource Management, Circular Economy, Solar Energy);
- 2. Project Progress update (all components);
- 3. Future workplans;
- 4. Updated risks

<u>Updates under Output 1.1 Sustainable Natural Resource Management and Community Livelihoods, covering:</u>

- 1. Status of NRM and community livelihoods, including the creation and strengthening of CPA systems
- 2. CBNRM support on Kulen Mountain, including gender assessments, grant agreements, stakeholder meetings and the identification of watershed areas

Updates under Output 1.2 Payment for Ecosystem Services (PES), covering:

- 1. Feasibility studies on Kulen Mountain and Kbal Chhay
- 2. Inter-ministerial PES meeting on PES and Social & Environmental fund, June 2019
- 3. National Dialogue on PES, September 2019

<u>Updates under Output 2, Circular Economy, covering:</u>

- 1. Circular Economy Pilots at the municipal and industrial levels
- 2. Strategic communication for plastic actions, including research on plastic challenges and solutions, development of policy measures for single-use plastics and promoting alternatives, raising awareness on plastic pollution, joint action through stakeholder engagement, and alternative business development

- 3. Development on enabling policies and measures for plastic recycling and circular economy policies
- 4. Proposed changes under Output 2, including piloting grass straws as an alternative to plastic straws, and facilitating the business challenge for organic composting and plastic recycling in 2020 instead of 2019

H.E. Victor Jona, Director General, General Department of Energy (GDE), Ministry of Mines and Energy (MME), provided updates on the status <u>Output 3 Solar Energy</u>, covering:

- 1. Improving access to energy supply and increasing the resilience of rural communities, including the identification of suitable off-grid solar technologies, and the clean energy and agriculture incubation program
- 2. Building the technical capacity for installation of solar, including training 20 engineers on design, installation and maintenance of off-grid solar systems
- 3. Communication and awareness raising, with a particular focus on women and other vulnerable groups
- 4. Development of scaling up strategies
- 5. Proposed changes to the project document

<u>Detailed Updates under Output 3.4, Support for the development of enabling policies and measures for solar energy, covering:</u>

- 1. Economic appraisal of the potential for photovoltaic solar energy in Cambodia
- 2. Study on policies and measures to address power shortages during the dry season
- 3. Technical assistance to TWG members on solar energy regulations
- 4. Development of solar guidelines for off-grid solar technologies

Mr. Oum Sony, Policy Specialist, UNDP, updated the project board, covering:

- 1. Overall Budget and delivery
- 2. Project Risks
 - Programme inputs are not mobilized in a timely fashion
 - Bank account requests took longer than expected to open
 - Budget allocated for some outputs may not be met, for example "200 households benefit from solar"
- 3. Strategies to ensure timely project implementation
 - Project manager (Sony) and Assistant (Sreykhouch) will spend two days a week at the MoE
 - LTAs, including communication, waste management and energy experts are now available
 - NCSD's newly formed project team
 - UNDP to provide additional technical support from various consultants
- 4. Changes in budget revision
- 5. Proposed changes for project board approval
 - Output 2
 - i. Support piloting grass straws as an alternative to plastic straws this year

ii. Business challenges for organic composting and plastic recycling will be facilitated in 2020 rather than 2019

Output 3

- i. Reduce the number of targeted households to be reached with solar system(s) under output 3.1, reduction from **200** to **100** households. Also proposed changing the number of targeted female-headed households from 50 to 25.
- ii. On request of MME, it is proposed to include: "Preparation of a guideline on solar home systems" in output 3.4. Part of budget from output 3.5 will be allocated to this activity.
- iii. Unexpected power shortages during dry season 2019, increased interest in ways to mitigate shortages. More interest in "Economic Appraisal of the Potentials of Photovoltaic Solar Energy in Cambodia"-study and related policy work.

It is proposed to add an indicator to the logframe of the project: indicator 3.7 "Studies and papers prepared to support RGC in evidence-based policy making towards a balanced, low-carbon intensive energy mix with a secure supply of power".

Budget

- i. Loss of exchange: \$91K is accounted for in resource mobilization
- ii. 2019 annual budget reduced from (-17%), but remaining is carried forward to 2020 (+20%) vs. initial budget (March 11)
- iii. Total budget change vs. approved initial budget (March 11) is ~2%, mainly for Component 1 and Project Management Cost.
- iv. New budget lines are created to reflect CoA and actual needs for project implementation (e.g. LTAs, PMU, field monitoring)

AGENDA ITEM 3: DISCUSSION SESSION

The presentation was followed by a number of questions/comments raised by participants. Key points are summarized as follows (please refer to Annex 1 for more detailed comments). The following remarks and recommendations were raised:

About the Project:

Ms. Johanna Palmberg (Embassy of Sweden), noted the following:

- Provided clarification regarding the exchange clause. After final decision was approved, the Swedish currency's value against the US Dollar changed. As the funds are disbursed in Swedish Krona, this resulted in a slight change due to the currency exchange, and not a drop in funding.
- Requested UNDP provide information regarding the new international expert (Leif), detailing his role within the BESD project and time allocation.

Response:

Mr. Leif Holmberg (UNDP)

- Briefly introduced himself as the new climate change and environmental policy expert, providing details on his past experience and his current role in supporting UNDP with environmental policy and climate change
- Clarified that a detailed workplan regarding his time allocation across all projects for the coming year will be discussed in October.

Dr. Moeko Saito Jensen (UNDP)

Specified Leif will take the lead on providing technical assistance to the government for air quality monitoring under Component 2, Circular Economy. In the coming months the project will initiate a work to develop a national circular economy policy. Leif will be providing his expertise in policy formulation.

About the project document:

Ms. Johanna Palmberg (Embassy of Sweden), noted the following:

- Noted an error in the name of the project mentioned within the mid-term report.
- Requested further clarification on the budgeting of the "Economic Appraisal of the Potentials of Photovoltaic Solar Energy in Cambodia"- study under Output 3.

Response:

Mr. Ivo Besselink (UNDP)

Clarified that the costs of the study, so the hiring of the contractor, for the "Economic Appraisal of the Potentials of Photovoltaic Solar Energy in Cambodia" is paid from UNDP resources. UNDP staff costs, to provide oversight/check work/provide quality assurance will be charged to the BESD project and paid from the financial resources from Sweden embassy.

AGENDA ITEM 4: CONCLUDING REMARKS

Conclusion

H.E. Dr. Ponlok thanked Sweden and UNDP for their continued support in implementing the project. Given the RGC's commitment and understanding of the costs of environmental degradation, he expressed the importance and relevance of the project in developing relevant models/approaches for environmental protection, biodiversity conservation, livelihood improvement, sustainable financing and provision of water and electricity. Noted the viability of the project to produce potential models for scaling up initiatives, and their potential push the current momentum towards environmental sustainability forward.

- The Project Board and implementing partners agreed to approve the budget revisions as well as proposed changes to the Project Document as presented during the meeting, with draft minutes and detailed budget revision to be made available via email
 - o If the budget is revised less than 10% among each component, the team can make these changes as it is within the limits of the project document, but the board should be informed in writing to track a record of those changes.
 - o Reducing targets and the new budget lines will not impact the overall project goal, therefore they should be acceptable.

Annex 1: Detailed comments made by participants

Ms. Sonali Dayaratne (UNDP)

Short project with 15 months remaining, while only 15 per cent of the budget has been spent. Due to time constraints, implementation will be challenging. But given the excellent leadership and partner coming together, hopeful the momentum will continue.

Ms. Johanna Palmberg (Embassy of Sweden), noted the following:

- Commended UNDP for presenting the budget and budget changes in a manner more understandable than the first meeting.
- Noted the importance of considering practicalities, including the process of opening bank account, and ensuring these practicalities are taken into consideration for future project planning so as to avoid delays.

Dr. Moeko Saito Jensen (UNDP)

- Provided clarifications on plastic initiatives, including an overview of several awareness raising activities including;
 - A cartoon and music video produced in collaboration with Laura Mam, including potential support from Aeon Mall II to provide the venue for the video shoot and the launch event for the video.
 - National forum on plastic, focusing on positive messaging for reducing single-use plastic, and promoting plastic recycling and engagement with varying stakeholders.
 While Aeon may participate, the venue has not yet been selected.

H.E. Dr. Tin Ponlok (NCSD)

- Stated the benefit of having Leif and having someone who has a new perspective for looking at these projects.
- Reviewed additional components on PES project including the two pilots, one in Phnom Kulen and one in Kbal Chay.
- Shared information of a number of related initiatives under the Department of Green Economy in line with Circular Economy including a proposed large-scale World Bank waste management initiative.
- Noted on a new half a million-dollar fund from Environment and Social Fund to be available for an investment in our youth.
- Expressed concern in regard to the future waste which will come from solar panels in 10-15 years. Asked how we can be better prepared for this.

Ms. Sonali Dayaratne (UNDP)

 Expressed the need to integrate the gender assessment into the components, design, activities and implementation of the project. UNDP will look further into how to best support implementing partners in this regard. Highlighted the importance of integrating gender components, as the project goes beyond producing communication materials specifically for women and ensuring their participation in activated, but rather the need to focus on gendered aspects from the inception of the project.

A) An Economic Appraisal of the Potentials of Photovoltaic Solar Energy in Cambodia

- As follow up on 'Derisking Renewable Energy Investment-study' with planned launch date in October: comprehensive study to model the impacts of investing in solar energy in Cambodia. Includes appraisals of externalities and assessment of economic impacts. As requested by MME, study will be aligned with the Energy Master Plan. Started Q1 2019, expected to be finalized Q1 2020.
- Establishment of a Technical Working Group (TWG) for study (MME, MoE, NCSD, MEF/SNEC, EDC, EAC)
 Launched April 2019 3 meetings so far

B) Study on the policies and measures to address power shortages during dry season

Policy paper with recommendations on addressing power shortages in the short-term. Provided to the TWG in July 2019

C) Providing Technical Assistance to TWG members on solar energy regulations

Financial modeling of scenarios with policy recommendations. April –September 2019

D) Developing 'Solar guideline' for off-grid solar technologies

Develop national guideline on off-grid solar technologies (conducted by international and national consultants). Workshops, consultations, and dissemination of information on solar guideline. Will start in Q3/Q4 2019. To be completed Q2 2020.

Proposed changes

Output 3: Solar Energy

- Output 3.1: It is proposed to reduce the number of households to be reached with solar system(s) under output 3.1 from 200 to 100 (and female headed households from 50 to 25). Target is not realistic given the high costs of realizing such system(s) in remote locations in Cambodia (also based on lessons-learned under CCCA project).
- Output 3.4. On request of MME it is proposed is include: "Preparation of a guideline on solar systems" in output
 3.4. Part of budget from output 3.5 is allocated to this activity.
- Output 3.4: Unexpected power shortages during dry season 2019, increased interest in ways to mitigate shortages. More interest in "Economic Appraisal of the Potentials of Photovoltaic Solar Energy in Cambodia"-study and related policy work.
- => It is proposed to add an indicator to the logframe of the project: indicator 3.7 "Studies and papers prepared to support RGC in evidence-based policy making towards a balanced, low-carbon intensive energy mix with a secure supply of power". (Target: "Economic appraisal of the potentials of Photovoltaic Solar Energy in Cambodia"-study finalised by Q1 2020). (Budget for contractor/consultants is coming from UNDP. Salary costs partly from BESD).



Key strategies to ensure timely implementation

- Project Manager (Sony) and Assistant (Sreykhuoch) will spend at least two days a week at the Ministry of Environment/NCDD-S to provide timely support for the implementation
- Long Term Appointments (LTAs): national communication, international waste management experts, energy experts are now available
- NCSD now set up a project team- comprised by 1) director, 2) coordinator, 3) admin and finance assistants and Government funded PMU (2 staff)
- LoAs with responsible departments will be fully implemented from September/October
- UNDP will provide additional support from the following staff for specific areas (part-time)
 - Intl Climate Change and Environmental specialist (funded by Sweden) for Output 1 & 2
 - Intl junior Environment and Circular Economy consultant for Output 1 & 2
 - Intl junior Energy and Clean Tech consultant (funded by UNDP) for Output 2 & 3



Proposed changes for the board's approval

- > Loss of exchange: \$91K -> Keep for resource mobilization
- ▶2019 annual budget reduced from (-17%), but remaining is carried forward to 2020 (+20%) vs. initial budget (March 11)
- ➤ Total budget change vs. approved initial budget (March 11) is ~2%, mainly for Component 1 and Project Management Cost.
- New budget lines are created to reflect CoA and actual needs for project implementation (e.g. LTAs, PMU, field monitoring)
