2015 QUARTER 1 REPORT

I. Executive summary

ACES project — "Associations of Councils Enhanced Services" — is aimed at turning the National League of Communes and Sangkats (the League) into an effective representative of local voices for democratic development. The project builds on the previous EU-UNDP support project for Democratic and Decentralized Local Governance (DDLG, 2006-2011) which enabled the establishment and the development of the League, the only Local Government Association in Cambodia. As the sole representative of Local Council interests, the League is critical to the successful outcome of the country's decentralization process participating in policy reform and project implementation.

The ACES project is aligned to the League's 2nd strategic plan 2011-2015 and the Royal Government of Cambodia's (RGC) decentralization policies, in particular the National Programme of Sub-National Democratic Development (NP-SNDD) 2010-2019 and its first Implementation Plan (IP3) 2011-2013.

The project substantially contributes to;

UNDAF" **Outcome 4:** By 2015, national and sub-national institutions are more accountable and responsive to the needs and rights of all people living in Cambodia and leading to increased participation in democratic decision making".

UNDP's CPAP outcome" **Outcome 4:** By 2015, sub-national Administrations have capacity to take over increased functions"

UNDP's CPAP output" *Output 4.3:* Local Government Associations are better able to advocate for their members and provide them services"

In response to CPAP outcome and output above, during this first quarter of year 2015, the Project Team focused more on the finalization of Practical Operation Management Manual (POMM, the structure of joint secretariat of both Associations, the Code of Conduct (CoC) of Local Association and the training conducts to leaders, secretaries and assistants of 6 Provincial Associations.

As the result of this quarter, ExCom meeting of both Associations organized to discuss and approve the structure of joint-secretariat. During this meeting, the key principles of Practical Operational Management Manual (POMM) for the joint secretariat of both Associations discussed and the Local Association's Code of Conduct (CoC) approved.

The training of project management and the Management and Operation Manual (MOM) conducted on 10th-13th March 2015 at Preah Sihanouk Province attended by PAs leaders, secretaries and assistants. The training is part of capacity development to 6 Provincial Associations to capacitate so that they are able to manage their membership fee and ACES grant budget in year 2015.

Last but not least, an annual audits conducted to ACES project by the BDO Co, LTD. The findings and recommendations presented to IP and the management responses prepared and submitted to UNDP CO.

II. Implementation progress

DELIVERABLE02: The League and its Provincial Associations have revised, improved and put into practice solid internal systems and procedures.

Two separate meetings organized to discuss the structure of joint-secretariat by both association's leaders and these meetings were facilitated by H.E Dy Sokphan, chair of MoI support team on January and March 2015 prior to ExCom meeting to be held on 5 March 2015 in Siem Reap.

The Practical Operational Management Manual (POMM) for joint secretariat of both Associations reviewed and the key principles discussed by technical staff in order to get approval from the ExCom members of both Associations during ExCom meeting to be held in Siem Reap province.

ExCom meeting of both associations (NACPC &NLC) organized on 05 March 2015 in Siem Reap province participated by ExCom members of both Associations with total attendants 110 (female 19). During this meeting, ExCom members of both Associations have discussed and approved the long-term structure of joint secretariat that consisted of 11 core staffs and the short-term vision consisted of 6 core staffs. For these six core staffs, both Associations is going to recruit base on the current availability of fund. It can be less than 6 core staffs at the first year. On the other hand, both Associations had also established the recruitment penal consisted of 7 members i.e. 3 members from each Association and 1 from Mol.

Key principle of POMM presented and discussed during this meeting. As it is more technical that needs to be carefully considered by the leaders, the meeting decided to assign Mr. Sam Nissay and Mr. Seth Sayon to come up with short presentation with options. Another meeting will be organized to discuss them with the leaders of both associations before getting approval from next ExCom meeting.

Code of Conduct (CoC) for Local Association has been presented during the meeting and finally, this Code of Conduct approved by the ExCom's members.

Annual audits conducted to ACES project by the BDO Co, LTD, started audits on 19-20 February 2015. The findings and recommendations of audits has been presented at the technical staff Meeting at NLC office. The management responses from IP has been submitted to UNDP CO.

Deliverable 3: The members of the governing bodies of the League and its 25 Provincial Associations have the analytical capacities to proactively develop policies, to communicate their opinions, and to supervise the activities of their respective secretariats

Four-day training on project management, leadership and Management Operation Manual (MOM) conducted to leaders, secretaries and assistants to 6 Provincial Association from 10th-13th March 2015 at Preah Sihanouk Province. The result of evaluation from attendants have shown that the training was fruitful. The attendants were consent with the topics and suggested to have more especially to conduct on MOM to internal auditors (7) so that these auditors are able to perform their duty. The total participants were 37 (11 females).
