<i>Briefly describe in the space below how the Project mainstreams the human-rights based approach</i>
The right to cultural heritage is an internationally recognized right in different human rights instruments and in the practice of human rights monitoring bodies, including the right to take part in cultural life and the right of members of minority groups to enjoy their own culture. This project aims to build trust between the communities in Kosovo through improved inter-community acceptance and respect for the cultural identity and heritage of all Kosovo communities. This will be done through the rehabilitation of cultural and religious sites in Kosovo, the promotion of intangible cultural heritage and the strengthening of institutions' capacities to protect and preserve cultural heritage. This project will allow communities, including ethnic minorities, to better enjoy their own culture as well as better understand the culture of other ethnic communities while contributing to the protection and preservation of cultural heritage in Kosovo.
<i>Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment</i>
A gender equality perspective is mainstreamed throughout the project, especially in the second component of the project that focuses on intangible cultural heritage. Intangible cultural heritage was included in the project as a tool to further expand the participation of women since they are more likely to be engaged in the production of traditional arts and crafts. Women will be the target of the first sub-activity of the second component that will focus on practical skills development for women and young people and will be actively encouraged to participate in the challenge prize competition that will be organized within the second sub-activity of the second component. The envisaged impact through this component is increased awareness and development of intangible cultural heritage as well as better socio-economic conditions for women.

The project is in line with the Kosovo strategies and laws related to Environment. Measures will be taken and applied to assure non-negative impact of the project, especially in the first component that focuses on the rehabilitation of cultural and religious sites.
