Project Performance and Results

Overview

National GPAR Programme Support Project was officially launched on 03 February 2012. This project aims to strengthen the capacity of public administration to deliver efficient, effective and accountable services to citizens through high level oversight and leadership, strategic management and support to all components of the national GPAR Programme in Lao PDR. This project is being implemented in alignment with other projects of the National GPAR Programme. The National GPAR Programme Secretariat enables the Ministry of Home Affairs in supporting the coordination and in implementing relevant component of the Strategic Plan on Governance (2011-20) of the Govt. of Lao PDR. The desired results by the end of this project is that effective high level oversight of Strategic Plan on Governance provides clear policy direction, with the National GPAR programme well coordinated and monitored across all programme clusters; and development assistance to the GPAR Programme is well coordinated and sufficient resources committed to support implementation of the different programme components.

The three outputs of the project are:

1. High level institutional mechanisms to provide oversight and coordination across the Governance sector established
2. Strengthening capacity in MoHA to effectively coordinate and monitor the implementation of the GPAR programme and related activities
3. Coordination of development partner assistance through the Governance Sector Working Group, and resource mobilization to support programme implementation

Overview of activities during period

The project had a limited set of activities to be carried out during this initial period. The main activities are listed below:

Programme Management Initiatives

1. High level institutional mechanisms:

- The National Leading Committee for the National GPAR Programme was approved by the Prime Minister. The Terms of Reference was drafted and revised, and is ready for discussion and approval.
- The nominations for the National GPAR Programme Board have been prepared, and are being circulated for approval by the Leading Committee for the National GPAR Programme.

2. Institutional Capacity in MoHA for Programme management:

- Steps for recruiting the initial national staff team for the project were completed. The team is now in place to implement the project.
- The Programme Management arrangements have been drafted and are being discussed in MoHA.
- The agreements with the Swiss Agency for Development Cooperation and UNDP Korea MDG Trust Fund have been completed.

3. Governance Sector Working Group:

- The draft Annual Work Plan for the Governance Sector Working Group for 2012 was prepared.
- Feedback was provided on generic Terms of Reference for Sector Working Groups

4. Preparations for Pre-Inception Workshop

Preparations were completed for the Pre-Inception Workshop of the programme, to ensure good understanding among the implementing departments. This Workshop will take place on April 9, 2012.

5. Workshop in Luang Namtha on possible GPAR collaboration with UNICEF

Preparations were completed for GPAR participation in a workshop at Lunag Namtha for discussing modalities and scope of partnership to implement the programme in the province in collaboration with UNICEF. This Workshop will take place from April 2 to 4, 2012.

The recruitment of the new staff for the NGPAR Secretariat Project took place during the quarter. Recruitment to all key positions has been completed.
