Dear Mrs. Oduor-Noah.

We refer to the Program Grant Agreement between The Global Fund to Fight AIDS, Tuberculosis and Malaria (the "Global Fund") and the United Nations Development Programme (the "Principal Recipient") for a malaria program entitled "Malaria Control and prevention through partnership", effective 23 June 2004 and amended by letters dated 1<sup>st</sup> March 2005, 2<sup>nd</sup> May 2005 and 30 May 2006 (as amended from time to time, the "Grant Agreement") Capitalized terms used but not defined in this letter have the meaning given to them in the Grant Agreement.

By signing this letter, the Global Fund and the Principal Recipient agree to amend the Grant Agreement by:
