Dear Atiba:

Through no fault of yours, it appears that neither Anne Marie (your predecessor) nor you were aware of UNDP's position (enunciated in the attached letter) that we would not be responsible for the gratuity payable to Mary Wilfred under her contract with the Government of Saint Lucia. In fact, despite her responsibilities as UNDP Focal Point, Mary is under contract with the Government of Saint Lucia and not UNDP, and we have simply facilitated the Government in its request that its TRAC resources be contributed towards her contractual payments.

Therefore, unless the attached letter (which indicates an insufficiency of funds and hence the inability of UNDP to cover gratuity) has been superseded by a subsequent letter or agreement, we should not have, and should not be paying for Mary's gratuity. Further, in any case, our contribution to her remuneration is restricted to the limit of Saint Lucia's available TRAC allocation.

Both DPS John Calixte and former PS Isaac Anthony received the attached correspondence on 1st June 2012, so they would understand that our contribution to remaining programmatic activities for 2013 would have to take into account the overpayment in respect of Mary Wilfred's gratuity.
