DRR Associate

Mr. Miyanawala welcomed all the participants to the first Project Board meeting of 2017. He briefly summarised the outcomes of the SLCDMP for the 2016, highlighting that the project teams were able to, achieve the targets for 2016. He indicated that work in the SLCDMP continued well last year despite the difficulties faced in the latter part of 2016.

He went on to welcome all new personnel from UN and the Ministry, to the project team of SLCDMP and C-CAP.

He ended his welcome speech by conveying his appreciation and thanks to the entire project staff at MDM, as well staff members at UNDP, DOM, NBRO and NDRSC for their participation and valuable contributions to the projects. Mr. Miyanawala emphasised that with the on-going drought, their assistance is further needed to complete project activities undertaken by the Ministry in the year 2017.

Following the Secretary's welcome speech, Ms. Lovita Ramguttee thanked the Secretary and the SLCDMP team for their contribution, and shared her comments on some important issues, including the on-going drought. She continued to state that although recovery aid is very important, following the Post Disaster Needs Assessment (PDNA) report, many long term needs have been identified for disaster risk reduction and stressed the importance of addressing these needs as well. Ms. Lovita also mentioned the importance of establishing data sharing platforms. She further requested ERD to address the issue of arrears on membership payments to UN and stated that the UNDP has agreed in principle to use this funds to support SLCDMP to continue the technical assistance provided to the Ministry and agencies under the purview.

She ended her speech by briefly discussing C-CAP and emphasising that 2017 is a crucial year for C-CAP. She was pleased with the initial findings from the recently conducted Mid Term Review and advised recommendations made to be taken very seriously, including the modification of the log-frame.

	 Furthermore, the funding gap for projects listed in the SLCDMP should be identified in order to inform the donors at the forum Ms. Lovita informed that there may be other donor forums being planned by other high level government agencies, which this team is not aware of, and to be cautious of such activities
SLCDMP	 Dr. S. Amalanathan, Additional secretary welcomed the participants to the meeting and presented a short presentation on the overall SLCDMP progress in 2016 and the work plan for 2017. He stated that approximately 103 billion LKR is required to implement the mid and long term recovery plan of PDNA
	 Mrs. Wasantha Samaraweera, Additional secretary commented that the next National Disaster Management Plan for 2018-2023 should be developed incorporating PDNA requirements, balance work of SLCDMP and the action plan prepared to achieve national targets outlined in SFDRR and SDG. She requested assistance from UNDP to develop the plan The project board provided their concurrence to PMU to implement the SLCDMP work plan for 2017
DATA Project	 Mrs Samaraweera presented a brief presentation on the activities implemented and the progress of the DATA Project for the year 2016 Furthermore, she explained and shared the list of consultancies plan to be hired in 2017
	 Mr. Chandradasa stated that the project proposes to develop a META data portal for Ministry of Mahaweli Development and Environment and Ministry

of Disaster Management as an initial step

- The portal will be expanded to store collected data from the agencies sharing data
- The project has developed a draft Agreement/MOU to facilitate the sharing of data between the Land degradation division and data generating agencies as an initial step
- Furthermore he stated that the data sharing policy has been drafted by the Technical Working Committee and submitted to obtain final comments from committee members
- Mr. Chaminda Pathiraja Director (NDRSC) requested consultation to prepare a database to monitor and report on the progress of achieving the SFDRR targets. He requested to include this requirement in the 2017 action plan
- He further emphasised the importance of identifying data required to report on SFDRR and requested the project to arrange a consultative meeting with data generating agencies to facilitate the sharing of data required to report in 2017
- The project board provided their concurrence to PMU to implement the Data Project's work plan for 2017
- Mr. Chaminda and Mr. Sampath presented C-CAP progress, the results from the Mid Term Review, the action plan for 2017, board papers and the HR map
- With regards to the board paper for the payments to the GAas administration fee, the Secretary suggested that when payments are made, it should be mentioned as a payment for their contribution and support for the entire project duration
- He further stressed that evaluation criteria should be made against physical targets
- Dr Buddika Hapuarachchi informed that the CCAP project has identified small scale land mitigation projects in Rathnapura District and requested the assistance of NBRO to implement these projects. The Project also planning to establish an agro-met station in Kurunegala or Puttalam District as a pilot activity and requested the support from Meteorological Department to identify a suitable location
- With all suggestions made above, the project board provided their concurrence to implement C-CAP's work plan for 2017
- Mr. Miyanawala emphasised the importantce of establishing and implementing a mechanism to coordinate and monitor all components of the
