PROJECT PERFORMANCE—IMPLEMENTATION ISSUES

The challenges experienced by the project in 2016 – beginning 2017 (cancellation of tender and underfunding) had been overcome by additional financial contribution by the Government and by changing the approach to tendering of construction works dividing them into three lots that resulted in lower financial offers. As the territory of the future facility shall be freed for full-fledge construction works, the need to arrange a temporary solution was identifies. This would allow the continuation of the border control in Palanca to benefit people and cargo movement across the border and men and women from Palanca village that shall cross the border to reach to their fields on the other side of Odessa-Reni high was.

LESSONS LEARNED

- 1. A temporary solution shall be provided from the outset of the project
- 2. Early engagement of the partner services in the design and implementation of the temporary solution was needed to ensure proper planning of the transfer of the necessary equipment to the temporary border crossing point.
- 3. Strong ownership by the national counterparts ensures a smooth implementation even when unforeseen circumstances emerge.
