#### Opening

The meeting was opened with remarks by the chair, U Kyaw Kyaw Lwin, Deputy Director of Forest Department. In his opening, he highlighted the important role of REDD+ Task Force to coordinate between and among all relevant REDD+ programmes, projects and initiatives in order to achieve consistency among all relevant REDD+ actions to be implemented in national territory. In addition, Task Force has to provide guidance and oversight for all REDD+ related programmes in Myanmar in order to support the effective and efficient development of all REDD+ actions in the country.

#### Session 1: Progress on Decisions of 1st TF meeting

Daw Khin Hnin Myint, National Programme Coordinator, UN-REDD Programme reported on the implementation of decisions set by 1st TF meeting and the progress can be seen in the table below.

#### Session 2: UN-REDD Programme in Myanmar: Achievements and Plan

Dr. Thaung Naing Oo, National Programme Director, UN-REDD Programme, Director, Forest Department, Secretary of Task Force described the achievements of the UN-REDD Programme and plans for 2018.

#### Achievements include:

- Taskforce established, supported by 3 "Technical Working Groups"; the purpose of these bodies is to support the development of the <a href="Myanmar REDD+ Programme">Myanmar REDD+ Programme</a> (not UN-REDD). These bodies have government, CSO, IP membership (plans to extend to private sector)
- > The UN-REDD Programme also has a governing body the "Programme Executive Board" (PEB)
- > Relationship between TF and PEB needs to be clear. TF Chair invited to brief PEB on TF activities at each PEB meeting
- ➤ A REDD+ Academy was conducted in 2016 now a team of 20+ REDD+ trainers. This team has been used for training provided to government agencies (FD and others), CSOs, and the media
- > Stakeholder engagement guidelines developed and implemented
- Consultation with 7 ministries on draft PAMs (June-Aug 2017); with each state/region on draft PAMs (started Nov. 2017; Magway and Kachin completed); and with the private sector on draft PAMs
- > Communications and knowledge management strategy developed and implemented: videos, TV/radio broadcasts, IEC materials etc.
- Safeguard Roadmap developed, 2017
- Policy/law/regulation review; and grievance redress mechanism contract issued in Dec., 2017
- ➤ NFMS Action Plan endorsed by September 2015
- ➤ Wall-to-wall mapping for 2005, 2010, 2015, supplemented by point sampling, to measure change in forest coverage, completed in 2017
- National Forest Inventory designed (now under further development by parallel FAO-Finland NFI/ NFMIS Project)
- ➤ Initial FREL to be submitted to UNFCCC on 8<sup>th</sup> January 2018. Scope is deforestation and enhancement through Myanmar Reforestation and Rehabilitation Programme; scale: National; carbon pools included: above-ground biomass, below-ground biomass and litter.

As result, National Emission Factor of 125.43 tonnes CO<sub>2</sub> eq per ha and annual CO<sub>2</sub> emission from deforestation during the reference period of 48,607,511 tons per year are developed. UNFCCC Technical Assessment process will take place during 2018.

> Drivers analysis completed, and National REDD+ Strategy drafted.

Dr. Thaung Naing Oo explained that currently Myanmar is near the end of "Phase 1" of REDD+, and plans are that by the end of 2018, Myanmar will be well into Phase 2.

#### Session 3: Other REDD+ Initiatives in Myanmar: Achievement and Plan

Dr. Yu Ya Aye, Forest Research Institute, Forest Department, spoke about "Capacity Building of Relevant Stakeholders for REDD+ Readiness of Myanmar".

U Thein Saung, Forest Research Institute, Forest Department, spoke about "REDD+ Himalayas: Developing and Using Experience in Implementing REDD+ in the Himalayas".

Dr. Ei Ei Swe Hlaing, Forest Research Institute, Forest Department described work on "Nesting a REDD+ project carbon accounting and monitoring system under the (sub-) national system"

U Ling Huang, Promotion of Indigenous and Nature Together (POINT), spoke on "Promoting the recognition and protection of indigenous peoples' rights in REDD+ in Myanmar".

#### Session 4: Way Forward for Task Force

Mr. Timothy Boyle, Interim CTA, UN-REDD Programme gave a presentation on issues that need to be considered in operationalizing Taskforce ToR. Recalling that the two objectives of the Taskforce are:

- 1. To provide <u>guidance and oversight</u> for <u>all REDD+ related programmes</u>, projects and initiatives in Myanmar.
- 2. To <u>coordinate</u> between and among <u>all relevant REDD+ programmes, projects and initiatives [to]</u> avoid duplication and contradiction between and among them

During his presentation, he highlighted a number of issues. These were:

- Challenge 1: What is a "REDD+ related programme? Some are clear, e.g., UN-REDD, KFS, ICIMOD. But what about the FAO/Finland National Forest Inventory project, or the One Map project?
- Challenge 2: Each initiative has its own governing body (e.g., UN-REDD has its PEB (Programme Executive Board)) do all these bodies acknowledge the role of the Taskforce? In the case of UN-REDD, this issue has been discussed by the PEB, and mechanisms designed to ensure coordination of oversight provided by the PEB and Taskforce. TF chair will be invited to PEB for information exchange.
- Challenge 3. Is it the role of the Taskforce to "approve" documents such as the FRL, National Strategy, NFI Design document, etc.?
- Challenge 4. A role of the Taskforce is to "... to <u>coordinate</u> between and among <u>all relevant</u> <u>REDD+ programmes, projects and initiatives</u> [to] avoid duplication and contradiction", but how to apply this in practice? As an example, do UN-REDD and KFS contradict each other, since UN-REDD is building capacity to implement REDD+ under the UNFCCC, while KFS has plans to develop a voluntary market project proposal?
- ➤ Challenge 5: Since the Taskforce "will work under the overall guidance of the Central Committee for Environmental Conservation and Climate Change", the CCECCC needs to be

- aware of and agree to this relationship, and functionality needs to be worked out how will it work in practice?
- ➤ <u>Challenge 6</u>: Taskforce currently has membership from Government, CSOs, and Indigenous Peoples' Organizations. A major stakeholder group that is missing is the <u>private sector</u>. The private sector is extremely diverse some private sector entities are involved in key drivers of deforestation and forest degradation; others are interested in PAM implementation either as CSR or from a commercial perspective
- Challenge 7: The TF has not been meeting monthly or quarterly, as indicated in its ToR. A TF Decision regarding its role in approving documents will contribute to indicating the optimum frequency of meetings. If the TF decides it should approve all documents, more frequent meetings will be needed than if the TF only approves "strategic" documents.

Possible solutions were proposed for each of these challenges.

#### **Decisions and Action points**

Decision 2/1: It was decided that the Taskforce should meet quarterly.

- Decision 2/2: The Taskforce requested that the UN-REDD Programme should undertake a detailed analysis of the costs, risks and benefits of mixing multiple forest carbon schemes, compared with a "REDD+ only" scenario.
- Decision 2/3 TF Secretary will prepare regular 3-month progress reports, and the TF Chair will report to DG and Minister on progress of REDD+ in order that this information can be presented at CCECCC meetings
- Decision 2/4: Other issues related to the operations of the Taskforce should be referred to Taskforce members in writing, at the same time as the Minutes of the 2<sup>nd</sup> Meeting of the Taskforce are circulated for comment, together with a recommended course of action, for approval on a "no-objection" basis.

#### **Next meeting**

The next Taskforce meeting will be scheduled in March, 2018.
