Agenda item 1: Opening

The meeting was opened with remarks by the Secretary, Dr. Thaung Naing Oo, Director of the Forest Research Institute, representing the Chair, U Kyaw Kyaw Lwin, Deputy Director of Forest Department. In his opening, he

Agenda item 2: Action taken to follow up on Decisions reached at the 3rd meeting of the Taskforce

Daw Khin Hnin Myint reported on the implementation of decisions reached at the  $3^{rd}$  meeting of the TF. Progress can be seen in the table below.

Further information on follow-up to Decision 3/3 was provided in a separate agenda item (see Agenda item 5, below).

In addition, follow-up action to Decision Supplemental 3 of the  $2^{nd}$  meeting of the Taskforce was presented, as at the  $3^{rd}$  meeting of the Taskforce, follow-up on this decision was omitted in error. Decision TF2/Supp 3 states:

"The TF will review only the final versions of those documents directly related to the "Warsaw Framework for REDD+". At its  $3^{rd}$  meeting, the TF will decide which of these documents should be referred to higher levels for approval"

The follow-up action undertaken was a proposal from the REDD+ Office regarding processes for approval of relevant documents:

#### Discussion

Members of the Taskforce discussed whether the ToR of the NECCCC (and its Working Groups) include authority to approve documents. The representative of the Planning Department asked for clarification on the relationship between the Taskforce and the NECCCC. In response, Dr. Thaung Naing Oo referred to Decision 2/3 of the Taskforce: "TF Secretary will prepare regular 3-month progress reports, and the TF Chair will report to DG and Minister on progress of REDD+ in order that this information can be presented at NECCCCC meetings". He noted that this information flow had not yet happened.

The Taskforce reached the following decisions related to the approval of RED+ documents:

**Decision 4/1**: The Taskforce defers making a decision on approval of Phase 3 documents (BUR Technical Annex and SOI) until Myanmar is in Phase 3.

**Decision 4/2**: The Taskforce instructs the Secretary to obtain clarification as to whether the NECCCC (and its Working Groups) have the authority to approve documents.

**Decision 4/3**: The Taskforce approves the proposal of the REDD+ Office regarding approval of Phase 1 documents, subject to clarification under Decision 4/2.

Dr. Tint Lwin Thaung (TNC, Observer), proposed that the database incorporate information on achievements by projects related to REDD+ in Myanmar.

**Decision 4/4**: The Taskforce instructs the Secretary to further develop the database of REDD+ related projects by adding information on achievements of each project.

#### Agenda item 3: Progress on REDD+ in Myanmar

Dr. Thaung Naing Oo described the progress on REDD+ in Myanmar in the context of the Warsaw Framework for REDD+, by the UN-REDD Programme, and by projects funded by ICIMOD and the Korean Forest Service. Under the UN-REDD Programme, the REDD+ strategy was revised with the comments and suggestions received by sub-national consultations, public consultation, individual group meetings and Drivers and Strategies TWG meeting. The FREL is assessing by UNFCCC's technical assessment team and the final version of FREL for approval is expected in November this year. The development of overall sampling design and field manual for National Forest Monitoring System is on progress. An addition to the UN-REDD support, the NFI/NFMIS project funded by Finnish Government will be started soon. As part of SIS (safeguard information system) setting, the national clarification on safeguard based on the benefits and risk of PaMs and PLR review is underway.

Through ICIMOD project, series of capacity building trainings such as training on REDD+ basic concept, forest inventory, carbon measurement and management of forest, livelihood improvement and nursery management were conducted for the government officials and communities in the project area.

Under the KFS project, the carbon stock and biodiversity survey have been accomplished and the training on Community Forestry and Agroforestry were conducted. Distribution of efficient stove to the community in the project area is one of its supports.

Daw Naw Ei Ei Min, the Director of POINT briefly presented the progress of the project "Community Forestry & Customary Land Tenure in the Context of REDD+ in Myanmar". The project developed several IEC materials and provided trainings and awareness/advocacy programme related to customary land tenure and rights and community mapping.

#### Discussion

Taskforce members and observers discussed a number of issues related to progress on REDD+:

- > Clarification was requested on the relationship between the MRRP and NDC, and the 30% target for PFE;
- > It was noted that there are relatively few projects or initiatives working of strengthening forest law enforcement;
- > For REDD+ to be successful, those who are "problem-makers" need to become partners how can this be affected?
- ➤ With regard to safeguards, information is needed on the relationship between REDD+ PAMs and safeguards. Also, information needs extend beyond the forest sector to other development sectors. What is the role of women in REDD+ in Myanmar?

**Decision** 4/5: The Taskforce instructs the Secretary to prepare a briefing on the role of women in REDD+ in Myanmar, for presentation to the  $5^{th}$  meeting of the Taskforce.

Agenda item 5: Further information on the issues that need to be taken into account in the negotiation of any bilateral initiatives related to emission reductions from forests

Mr. Timothy Boyle, CTA, UN-REDD/Myanmar, gave a presentation on five issues emerging from Document 3/5, presented to the 3<sup>rd</sup> meeting of the Taskforce. These are:

- 1. Any bilateral forest carbon initiatives which involve a transfer of title to forest ERs and involve the GoM as the seller would make it harder to achieve emission reduction targets specified in the NDC.
- 2. Bilateral (and multilateral) forest carbon mechanisms use methods for calculating emission reductions and an emission "baseline" that are similar to, but usually differ to some degree from those used under REDD+.
- 3. The potential to increase revenues from forest ERs depends on the relative prices paid under REDD+ and the bilateral (or multilateral) mechanisms.
- 4. The timing of receiving revenues is difficult to predict.
- 5. Transactions of forest ERs that do not involve Parties to the UNFCCC are not affected by Article 4 of the PA¹.

Further information was provided on each of these issues, leading to the conclusions/recommendations:

REDD+ only	Mixed mechanisms

<sup>&</sup>lt;sup>1</sup> Since the Paris Agreement applies only to Parties to the UNFCCC, transactions of Er's that do not involve Parties to the UNFCCC are not bound by the terms of the Agreement

Costs	Considered as the default	Costs higher due to need for registry and (especially) reconciliation of MRV data
Revenues	Assume \$5/tonne (maybe discounted if through GCF)	Probably similar – prices similar and most mechanisms also discount or have buffers could be higher if Gov not a party BUT additional cots of C-rights legislation
Risks	As defined in NRS	Risks higher – e.g., potential for conflicts among beneficiaries of different mechanisms
Benefits	As defined in NRS	Difficult to predict; depends in part on safeguards systems of different mechanisms

- > From a purely technical perspective, there are no clear reasons to pursue non-REDD+ mechanisms.
- There may be other reasons (e.g., political) to pursue non-REDD+ mechanisms. An objective, quantitative assessment of whether the non-technical reasons for pursuing other mechanisms outweigh the technical reasons not to is not possible.
- > However, the decision should be based on a clear understanding of the costs, revenues, risks and benefits of the alternative mechanism
- > The GoM should insist that an analysis clarifying costs, revenues, risks and benefits should be conducted by the party proposing the non-REDD+ mechanism <u>before any agreement is signed</u>, so as to allow the GoM to take an informed decision

Taskforce members and observers discussed this information and reached the following two decisions:

**Decision 4/6**: The Taskforce requested that a further agenda item on this topic be included at its 5<sup>th</sup> meeting

**Decision 4/7**: The Taskforce agreed that the GoM should insist that an analysis clarifying costs, revenues, risks and benefits should be conducted by the party proposing the non-REDD+ mechanism <u>before any agreement is signed</u>, so as to allow the GoM to take an informed decision.

## Agenda item 7: The revised National REDD+ Strategy

Due to lack of time, this agenda item was deferred to the next meeting of the Taskforce.

## Agenda item 9: Updates on mangrove initiatives related to REDD+

Daw Zin Myo Thu, Head of Office, IUCN Myanmar Programme shared about the project "Integrating Mangroves into REDD+ Implementation in Myanmar" which is funded by Norad. The project is aimed to have better protect to the Mangrove Forests in Myanmar with National REDD+ Instruments. The project implementation will be started in 2019 with the duration of 3 years. It will cover 5 districts under Ayeyarwaddy, Rakhine and Tanintharyi Region. The project expects to have REDD+ responsive revised DFMPs (District Forest Management Plans) by covering 30,000 hectares of Mangroves outside PEF (Permanent Forest Estate) into Reserved Forests, Community Forests and Community Protected Areas. The project will try to strengthen the capacity of District Forest Officers to engage stakeholders in mangrove management.
