Agenda item 1: Opening

The meeting was opened by U Kyaw Kyaw Lwin, Chair of the TF, Deputy Director General of the Forest Department. He pointed out that as the number of activities under the Myanmar REDD+Programme increase, so does the importance of TF decisions, so he encouraged all the members to continue to support its activities.

Agenda item 2: Action taken to follow up on decisions reached at the 7th meeting of the Taskforce

Dr. Thaung Naing Oo, the Secretary of TF reported on the implementation of decisions reached at the 7th meeting of the TF. Progress can be seen in the table below.

Agenda item 3: Progress on REDD+ in Myanmar

Dr. Thaung Naing Oo, the Secretary of TF updated the progress of REDD+ in Myanmar in the context of the Warsaw Framework for REDD+. Engagement with ethnic nationalities for consultation on the draft REDD+ Strategy has continued. This process has been completed for Chin, RCSS, PNLO and Kachin and is on-going for KNU.

In relation to GHG data, a high-level meeting between the DGs of ECD and FD was held on 28th May 2019 and a follow-up technical meeting is still needed. The Field testing on Field Methodology of National Level Forest Inventory in 6 districts was already finished around mid-April and the Field-Testing Feedback workshop had been organized on 11th to 13th of July. The initial results of the field data including soil data have been presented in the workshop together with the time study analysis of the field testing. The Field Methodology has been updated in accordance with the experiences learnt from the field testing.

The identification of information needs for the SIS and the assessment of information systems & sources relevant to the SIS has already been accomplished and a draft design for Myanmar's SIS has also been prepared. The discussion on operationalization plan for establishing the SIS is undergoing. Setting up SIS operationalization plan that sets out the technical, human resources and financial needs, detailed data template of data collection from each sector need to be done in 2019. The first draft of the SOI (Summary of Information) has already been prepared with the support of SOI drafting group members. For developing FPIC guidelines, the piloting at the Community Level in Mawlamying District is on progress.

For REDD+ Strategy implementation, the UN-REDD prepared a proposal in cooperating Mangrove into REDD+ Implementation and submitted to Norad. in June 2019. The proposed activities would be added to the existing UN-REDD/Myanmar Programme under a new Outcome, Outcome 6.

Discussion

The Chair pointed out that options will need to be prepared for the Climate Summit in NYC in September, including emission reduction targets. He suggested that it should be a target to get formal approval of the Strategy before the end of the year.

Agenda item 4: Proposal for National Validation Workshop for the REDD+ Strategy

Mr. Timothy Boyle, CTA, UN-REDD Programme Myanmar presented the proposal for National Validation Workshop on Myanmar's draft National REDD+ Strategy. After more than 50 consultation processes with different stakeholders, the final validation workshop on the strategy is planned to be organized on 10-11 September 2019 in Nay Nyi Taw. The representatives from different line agencies, CSOs, NGOs/INGOs, Ethnic Armed Organizations and Ethnic Political Parties will be invited. He briefly explained the tentative agenda of the workshop. Before conducting the national validation workshop, the pre-meetings with relevant departments who need to lead the implementation of specific Policies and Measures (PaMs) set out in the REDD+ Strategy, will be conducted. At that same time, the Drivers & Strategy Technical Working Group meeting will be organized before the workshop to have discussion on plan for the validation workshop.

Discussion

TF commented to distribute the draft strategy (both English and Myanmar version) to the participants ahead of the workshop so that the participants can review the contents of the strategy and provide the concrete comments during the workshop. (Decision: 8/1). TF suggested to set facilitators ahead and do preparation for the workshop (Decision: 8/2). As private sector is important for REDD+ Strategy Implementation, private sector should be invited to the validation workshop (Decision 8/3).

Agenda item 6: Safeguard Information System (SIS) design and institutional arrangements, and update on SOI (Summary of Information) development

Daw Khin Hnin Myint, Programme Coordinator of the UN-REDD Myanmar shared the progress and plan of SIS and SOI for Myanmar. The proposed design of SIS has already been drafted and SIS operationalization plan under development, with plans to consult experts/stakeholders in October 2019. The SOI drafting group was established in May and the draft SOI has already prepared and it is now under revision by reflecting the comments of 2nd drafting group meeting in July 2019. She briefly explained on draft design of SIS and structure. A key issue needs to be addressed on SIS design is to identify host institution for the SIS database. She highlighted the comments of SOI drafting group meeting in July which is the revised workplan for SOI development. To have quality first SOI of Myanmar, to have selected consultations with local stakeholders to gather information on perceived social and environmental impacts and integrate results into the draft SOI, providing some additional information on the respect aspect in 2020.

Discussion

There was discussion among TF members about identifying host institution for SIS database: Forest Department (or) Central Statistics Organizations (CSO)? No decision was reached during the meeting as there was no CSO representative at the meeting and nobody was aware of its interest to host SIS. In order to facilitate decision-making at the next TF meeting, the UN-REDD Team was asked to confirm CSO's interest in being host and to invite CSO representative to the next TF meeting during their planned meeting with CSO on 6th Aug 2019 (Decisions: 8/4 and 8/5). If CSO is not interested to host, FD will take that responsibility. (Decision: 8/6)

Agenda item 8: Progress in developing guidelines on the application of FPIC

Mr. Timothy Boyle, CTA, UN-REDD, Myanmar gave initial briefing on the progress in developing guideline on the application of FPIC. He explained the piloting FPIC in Mon State. Discussion has been held with the Mon State Chief Minister and Forest Department and the New Mon State Party for methodology and approach of the piloting. Field visits have been made to 11 Village Tracts, as a result of which, 9 Village Tracts have been selected for the pilot. Community consultations following the pilot methodology are expected to take place in August. In parallel with UNDP piloting in the field, WCS

have been requested by the Forest Department to develop a standard operations procedure for FPIC to be applied in the gazetting of future protected areas. In order to avoid duplication or contradiction in these parallel processes, a small, informal "working group", consisting of UNDP/UN-REDD, WCS, WWF, and POINT has been established to exchange information and ensure effective progress. A national workshop on FPIC is tentatively planned for September 12th.

Discussions

The Chair pointed out that the specific FPIC process need to be identified based on the required fields/nature of the projects although the overall FPIC concept is the same. It will be different process/tools for different activities. TF recommended to invite RECOFTC to be member of informal FPIC working group as RECOFTC provide training on FPIC (Decision: 8/7).

Agenda item 10: Update on proposals for REDD+ implementation in mangroves

Mr. Timothy Boyle, CTA, UN-REDD, Myanmar presented the proposal for REDD+ implementation in mangroves. As per invitation of Norway, UN-REDD submitted a proposal in June 2019. He highlighted the expected Outcome and Outputs of the proposal. The proposed activities would be added to the existing UN-REDD/Myanmar Programme under a new Outcome.

Decision TF 8/7: TF recommended to invite RECOFTC to involve in the FPIC informal working group as it is providing training on FPIC.
