Agenda item 1: Opening

The meeting was opened by U Kyaw Kyaw Lwin, Chair of the TF, Deputy Director General of the Forest Department. He highlighted the fine progress of Myanmar REDD+ programme and acknowledge the supports of the REDD+ TF for the significant progress.

Agenda item 2: Action taken to follow up on decisions reached at the 7th meeting of the Taskforce

Dr. Thaung Naing Oo, the Secretary of TF reported on the implementation of decisions reached at the 8th meeting of the TF. Progress can be seen in the table below.

Agenda item 3: Progress on REDD+ in Myanmar

Dr. Thaung Naing Oo, the Secretary of TF updated the progress of REDD+ in Myanmar in the context of the Warsaw Framework for REDD+.

In term of Strategy Development, engagement with ethnic nationalities for consultation on the draft has already been accomplished. The final National Validation Workshop was conducted on September and the revision of Strategy is under process. In relation to FREL/FRL, a discussion with the Environmental Conservation Department (ECD) took place on issues on consistency between the GHG-Inventory as under preparation during the SNC process and the implications for the revision of the NDC. No results as yet from these discussions. The next update of the Forest Reference Level (FRL) is planned for 2021 when more data from National Forest Inventory (NFI) and updated forest cover maps are available.

As the progress of setting National Forest Monitoring System (NFMS), the field methodology for the NFI has been further revised and an updated version as of October 2019 is available. A high-level meeting with national NFI experts will be conducted on 1st November 2019 in Yangon in order to carry out a final consultation on NFI methodology before the start of the upcoming field season (2nd field testing and NFI work in Mangroves of Southern Myanmar). For the work on the NFMS Web-GIS portal this year, in the end, the decision was made to use OneMap Myanmar as the basic platform. Former ideas of developing a separate web-based platform or adding the Myanmar NFMS to a Servir Mekong platform, after several technical discussions, were dismissed. A draft NFMS module on OneMap was established in September and the process of uploading REDD+ and forestry relevant information layers is ongoing.

For SIS setting, following the development of draft design for Myanmar's SIS during the first half of 2019, discussion on operationalization for the SIS has started and is still ongoing. Unfortunately, we lost our SIS consultant back in July and only now are able to select a successor. The tasks for the remainder of the year and most of Q1 2020 will be dedicated to further develop the SIS operationalization plan that sets out the technical, human resources and financial needs with a detailed data template of data collection from each sector. The 2nd draft of the SOI (Summary of Information) has already been prepared with the support of SOI drafting group members and the consultation workshop will be conducted on 24 October 2019. The piloting at the Community Level in Mawlamyine District for the development of FPIC guideline is ongoing and expect to finish by end of October 2019.

Agenda item 4: Results of National Validation Workshop for the REDD+ Strategy (Sept. 10-11) and next steps

Mr. Timothy Boyle, CTA, UN-REDD Programme Myanmar presented the outputs of the National Validation Workshop on Myanmar's draft National REDD+ Strategy. A total of 130 comments and recommendations were generated during the workshop (not counting comments on the lack of accuracy of the Myanmar translation). Subsequently, additional comments were submitted by the Forest Department, MTE, and CAT. The majority of the comments were minor, many of an editorial nature. By far the most substantive comment was submitted by the Forest Department after the event. The Forest Department decided that it did not want to be ambitious in implementing REDD+, and instead of seeking to achieve a zero net deforestation target by a specific date, simply to aim to reduce the rate of deforestation by 30% by 2030.

He explained that the National REDD+ Strategy will be amended accordingly and submitted for approval. Since (especially by 2030) a significant proportion of the remaining forest will be in territory controlled by Ethnic Armed Organizations, it is proposed that a NCA-S REDD+ Action Plan also be developed. This would establish targets decided by NCA-S EAO's.

Decision

To decide the specific target for REDD+ Strategy, TF asked UN-REDD to prepare the 4 different scenarios with very low to high ambitious target by highlighting the priority PaMs to reach to each scenario (decision 9/1). FD will decide the target after reviewing those scenarios (Decision: 9/2)

Agenda item 6: Decision on hosting of SIS

Daw Khin Hnin Myint, Programme Coordinator of the UN-REDD Myanmar updated on discussion with the Director General of CSO for the decision on hosting SIS. Responding to Decision TF 8/4, the UN-REDD Team did meet with CSO on 6th August 2019. During which meeting CSO indicated a willingness to serve as host of the SIS. Responding to Decision TF 8/5, CSO has been invited to participate as a member of the National REDD+ TF. Consistent with Decision TF 8/6, Daw Khin Hnin Myint invited the TF members to set the decision on hosting SIS database.

Discussion:

CSO representative mentioned DG's willingness on hosting SIS database.

Decision:

TF decided CSO as a host institution for SIS database. Forest Department will do any necessary formal process for the decision (Decision 9/3). TF recommend UN-REDD to have further discussion with CSO the development of SIS Operationalization Plan (Decision 9/4).

Agenda item 8: Plans for national FPIC consultation

Mr. Timothy Boyle, CTA, UN-REDD, Myanmar gave initial briefing on the plan for conducting workshop on the development of FPIC guideline. At its 8th meeting, the TF was presented with the information on the development of FPIC guidelines. The National Consultation on FPIC was planned for September 11th, a day after the National Validation Workshop on the REDD+ Strategy, to take advantage of so many stakeholders already being present. However due to the delay of UNDP's piloting in Mon State due to the catastrophic flooding and landslides in the are in July and FD had not yet received a first draft of the SOP for protected Areas being developed by WCS, Director General of Forest Department commented to postpone the workshop.

He informed that the date for the National Consultation will be re-scheduled during November. The results of UNDP's piloting are now available, but the draft Standard Operating Procedures being developed by WCS are still awaited.

Agenda item 10: Update on approval of Norwegian funding for REDD+ implementation in mangroves

Mr. Timothy Boyle, CTA, UN-REDD, Myanmar updated on proposal of Norwegian Funding for REDD+ implementation in mangroves. At its 8th meeting, the Taskforce was presented with information on a request to Norway for funding to support REDD+ implementation in mangrove ecosystems. Norad reviewed the submission from UN-REDD and identified a few issues where further information was requested. Submission was "technically cleared" by Norad, although additional information requested on stakeholder engagement, a human rights-based approach, risk management, and conflict sensitivity. Initial indication of funding becoming available in 2019 has not yet materialized, but still possible this year. Although total requested budget was USD 2.3 million, total funding is also still not finalized. The fund will be transferred to regional UN-REDD "Implementing REDD+" project, but ear-marked for Myanmar mangroves and it does not require approval of the UN-REDD Executive Board. The implementation arrangements can follow current institutional set-up, however, the significant problem is that current UN-REDD PMU will dissolve in March/April 2020.

Discussion:

TF had discussion on funding gap after March/April 2020 as the UN-REDD PMU Staff Salary will be ended in March/April 2020.

Decision:

In order to avoid financial gap, TF recommended to do follow up with Norway to get funding support before March/April 2020 (Decision 9/5)
