#### **Opening**

The meeting was opened with remarks by the Secretary, Dr. Thaung Naing Oo, Director of the Forest Research Institute, representing the Chair, U Kyaw Kyaw Lwin, Deputy Director of Forest Department. In his opening, he highlighted the mandate of TF to provide guidance and oversight for all related REDD+ programme, projects and initiatives in Myanmar. He mentioned the implementation of Myanmar REDD+ Programme is being accelerated through several initiatives in which the overall guidance of TF is crucial for effective implementation of the whole programme. He concluded his opening by encouraging to all the TF members for their fruitful discussion on how the TF will manage all the REDD+ initiatives in Myanmar.

**Session 1:** Action taken to follow up on Decisions reached at the 2<sup>nd</sup> meeting of the Taskforce Dr. Thaung Naing Oo reported on the implementation of decisions reached at the 2<sup>nd</sup> meeting of the TF. Progress can be seen in the table below.

## Session 2: Progress on REDD+ in Myanmar

Dr. Thaung Naing Oo described the progress on REDD+ in Myanmar. He noted that by the end of 2017, Myanmar was nearing the end of Phase 1 of REDD+, and by the end of 2018 it was expected to be well into Phase 2.

#### (a) National REDD+ Strategy

#### (b) Forest Reference Emission Level

On 8<sup>th</sup> January 2018, Myanmar submitted its initial Forest Reference Emissions Level (FREL) to the UNFCCC and a process of Technical Assessment has begun.

#### (c) National Forest Monitoring System

An action plan for NFMS was developed in 2015 and implemented from the same year; it is not yet available on the REDD+ Myanmar website. The data collection approach for the NFI is still in the piloting phase and the final decision on which carbon pools will be included in field measurements not yet fully decided.

#### (d) Safeguards Information System

A Safeguards Roadmap was developed in 2017 under the auspices of the Technical Working Group on Stakeholder Engagement and Safeguards. The safeguards roadmap provides information on the proposed goals and scope of Myanmar's safeguards approach, an overview of UNFCCC safeguards requirements, and a description of completed or ongoing initiatives in Myanmar that are relevant to its safeguards roadmap.

#### Phase 2 activities under implementation

Some policies and measures to reduce net emissions from forests are already under implementation. Since the NLD government took office, there have also been several policies and measures designed to reduce degradation of forests due to over-harvesting of timber. These include:

- A one-year logging moratorium, and a 10-year logging moratorium in Bago Region;
- A substantial reduction in "annual-allowable cuts" for both teak and other hardwoods –
  and a commitment to harvest well below the annual allowable cuts;

- Reform of the Myanmar Timber Enterprise;
- The passage of a new Forestry Law, with significantly increased penalties for all forest crimes, particularly illegal logging.

#### Looking ahead to Phase 3

The Green Climate Fund recently launched a pilot programme of results-based payments for countries which have results to report for the period 2014-2018, and which meet the requirements of the Warsaw Framework for REDD+ by 2022. The potential for Myanmar to take advantage of this pilot programme is currently being assessed.

Dr. Thaung Naing Oo explained that currently Myanmar is near the end of "Phase 1" of REDD+, and plans are that by the end of 2018, Myanmar will be well into Phase 2.

## Session 3: Issues arising from decisions of the 2<sup>nd</sup> meeting of the Taskforce

A) Database of REDD+ relevant projects and programmes, and the definition of "REDD+ relevant"

Daw Khin Hnin Myint, Programme Coordinator, UN-REDD/Myanmar, gave a presentation on actions undertaken by UN-REDD in response to TF Decision Supplemental 1. Through a variety of processes, the database amounts to 113 projects, valued at about \$1.4 billion. Three possible criteria were presented to determine which of the 113 projects the Taskforce should consider "REDD+ relevant. These were:

- 1. Those projects and programmes that contribute directly to one or more of the four elements of the Warsaw Framework for REDD+ (most restrictive). There are **six** such projects. The total funding for these projects amounts to about USD 14,500,000.
- 2. Those projects and programmes that primarily address climate change and forests. There are **17** such projects. The total funding for these projects amounts to about USD 480,745,000.
- 3. Those projects and programmes that include some component related to climate change and forests (most broad). These are represented by blue shading in the Annex. The total funding for these projects amounts to about USD 963,350,000.

The Taskforce discussed the implications of adopting narrower or broader criteria and reached decision 3/1. The Taskforce also requested the UN-REDD to keep the database regularly updated – Decision 3/2.

B) Costs, risks and benefits of engaging in forest carbon initiatives other than REDD+

Mr. Timothy Boyle, CTA, UN-REDD/Myanmar, gave a presentation on five forest carbon initiatives: REDD+, FCPF Carbon-fund, REDD+ Early Movers; the Joint Crediting Mechanism (Japan) and the Voluntary Carbon Market. The analysis looked at four issues: who participates in the mechanism, the carbon accounting methods, whether there is transfer of title, and the scale of the initiative. The table below summarizes these issues.

A set of recommendations emerging from the analysis was presented to the Taskforce and discussed. Taskforce members felt that because the issues are quite complex, they required more time to assess the recommendations. The Taskforce reached Decision 3/3 and asked that the issue be raised again at the next Taskforce meeting.

#### Session 4: REDD+ Information Exchange

- A) Chin Human Rights Organization

  Daw Rose Enn Tin Sung, Project Officer, CHRO, described the activities of CHRO, particularly focusing on respect for the rights of indigenous peoples.
- B) FAO/Finland National Forest Inventory Project Dr. Franz Arnold, CTA, described plans for the FAO/Finland National Forest Inventory Project, which has not yet been signed.
- C) Worldwide Fund for Nature Mr. Gaurav Gupta, Sustainable Business Programme Manager for WWF/Myanmar, gave a presentation on WWF activities relevant to REDD+.

#### **Decisions and Action points**

- Decision 3/1: Initially, the mandate of the Taskforce to provide guidance and oversight to "REDD+ relevant" project and programmes will adopt the criterion that such programmes and projects should contribute directly to one or more of the four elements of the Warsaw Framework for REDD+. (These programmes and projects are listed in Annex 1 to these minutes).
- Decision 3/2: The Taskforce requested that the UN-REDD Programme should regularly update the database of programmes and projects that may contribute to REDD+.
- Decision 3/3 The Taskforce requested the UN-REDD Programme to provide more information on the issues that need to be taken into account in the negotiation of any bilateral initiatives related to emission reductions from forests.
- Decision 3/4: In preparation for the 4<sup>th</sup> meeting of the Taskforce, which will focus on approval of the National REDD+ Strategy, the UN-REDD Programme is requested to circulate the revised version to Taskforce members well in advance of the meeting to allow them to prepare.
- Decision 3/5: Given the importance of mangroves for REDD+, the information exchange session of the 4<sup>th</sup> meeting will focus on mangroves.

The next Taskforce meeting will be scheduled in June, 2018.
