ADDENDUM NUMBER 2 TO AGREEMENT BETWEEN THE NORWEGIAN MINISTRY OF FOREIGN AFFAIRS AND THE UNITED NATIONS DEVELOPMENT PROGRAMME COUNTRY OFFICE MONTENEGRO CONCERNING THE PROJECT “IMPROVING THE EFFICIENCY OF JUSTICE SYSTEM”

UN ref. no: MNE_00187_0818, the Donor ref. no MNE-18/0002, 18/8471 and 14/13609 (PRIS project)

WHEREAS the Norwegian Ministry of Foreign Affairs (MFA) and UNDP Country Office Montenegro (the Partner) (jointly referred to as the Parties) have entered into an agreement dated 1 August 2018 (the Agreement) concerning MNE-18/0002 UNDP - Improving the Efficiency of Justice system (the Project), Addendum 1 that has been signed on 27 March 2021.

WHEREAS the Partner in a letter dated 30 May 2022 has requested another extension of the Support Period and revised Budget and revised Results Framework with which MFA has decided to partially comply offering 12 months extension period instead of requested 18 months, and the Partner in a letter dated 7 July 2022 accepted 12 months extension,

NOW THEREFORE the Parties have reached the following understanding, which shall constitute Addendum number 2 to, and be an integrated part of, the Agreement:

1 EXTENSION OF THE SUPPORT PERIOD

1.1 The Support Period set forth in the Agreement shall hereby be extended to 30 June 2023.

2 ADDITIONAL AND REVISED CONDITIONS

The project will be implemented in line with the revised Budget and the revised Results Framework attached as Annex A and Annex B to this Addendum.

3 REMAINING CONDITIONS OF THE AGREEMENT

3.1 The donation will cease to support salaries of the project team and study trips from 30 June 2022. All other provisions of the Agreement shall remain unchanged and in force.

4 ENTRY INTO FORCE AND DURATION


4.1 The Addendum shall enter into force on the date of the last signature, and remain in force until all obligations arising from it have been fulfilled.
