Podgorica, 03. 08. 2015 god. **AMENDMENT # 2 TO THE CONTRACT**

BETWEEN

UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP)

AND

THE SOCIAL WELFARE CENTER PODGORICA

Reference is made to the Cost Sharing Agreement (hereinafter "Agreement) signed on 29th July 2014 and Amendment # 1 to the Agreement signed on 22nd July 2015 between the UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP), and the Social Welfare Center Podgorica (SWC Podgorica), with respect to the Project "Developing facilities for provision of social services in Montenegro".

Therefore Parties hereby agree on the following:

WHEREAS the SWC Podgorica and UNDP now wish to amend the said Agreement in order to define new amount and payment schedule;

WHEREAS such Amendment will result in an increase of **90,000.00 EUR** making this amended Agreement amount total **242,000.00 EUR**;

NOW THEREFORE, the relevant Agreement provisions indicated below are hereby amended to read as follows:

Article I

1. The SWC Podgorica shall, in the manner referred to in paragraph 2 of this Article, place at the disposal of UNDP the contribution of 242,000.00 Euros.
2. The SWC Podgorica shall, in accordance with the schedule of payments set out below, deposit the contribution to the bank account # 510000000102164417 in Crnogorska Komercijalna Banka (CKB) - beneficiary UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP).
