# 1.Duration of the Project

The Project will be extended under the same title until the end of 2015 in the aim of:

- 1. strengthening the capacities of the Government of Montenegro to lead EU Accession Negotiation process on Chapters 23 and 24, and in particular capacities of the Ministry of Justice, which leads Working group for negotiation on the Chapter 23; and Ministry of Interior which leads the Working group for negotiation on the Chapter 24;
- 2. improving legislative and administrative framework in line with the EU conventions and standards that will enable more effective international judicial cooperation in criminal matters:
- 3. further strengthening of the capacities of the Ministry of Justice of Montenegro, its Directorate for anti-corruption (DACI), courts and public prosecutor offices to fight corruption and conflict of interest more efficiently through the development and implementation of integrity plans for the purpose of fulfilling international standards in the scope of the rule of law reform.

#### 2. Total resources required and allocated

The total resources required and allocated are increased due to the introduction of new activities within the Component III, and thus the overwiew of the resources is the following:

# 3. Revision of activities related to Component (3)

The activities within Component (3): Raising understanding of European integration and of international legal assistance/co-operation processes will be complemented by new activities within three broad areas:

- A. Negotiation process on Chapters 23 and 24;
- B. International legal assistance in criminal matters;
- C. Fighting against corruption through the development of integrity plans.

The planned activities are listed here as per the defined areas of intervention:

#### A. Negotiation process on Chapters 23 and 24

The activities for Component (1): Capacity development of the Ministry of Justice and Working group for Chapter 23 will include the following:

- 1. Support for the finalization of the Action Plan for Chapter 23
- 1.1. Support in harmonization of national legislation with the *acquis*, covered by the Action plan for Chapter 23 (with specific focus on the international standards in the area of the rule of law and human rights protection / reform of judiciary, anti-corruption policy, anti-discrimination, personal data protection and other human rights protection issues);
- 2. Support for development of National Programme for Accession related to Chapter 23
- 2.1. Provide comparative experience from acceding countries and EU members states on implementation of specific measures defined by the National Programme for Accession
- 3. Provide support for monitoring of the implementation of the Action Plan for Chapter 23 with the specific focus on Strategy and Action Plan for the Reform of Judiciary (2013-2018)

The activities for Component (2): Capacity Development of the Ministry of Interior and Working group for Chapter 24 will include the following:

- 4. Support for the finalization of the Action Plan for Chapter 24
- 4.1. Support in harmonization of national legislation with the acquis covered by the Action plan for the Chapter 24 (with the specific focus on asylum, border control, Action Plan on implementation of Strategy on integrated border management, Schengen Action plan, Judicial Cooperation in civil and criminal matters, etc.)
- 5. Support for development of National Programme for Accession related to Chapter 24
- 5.1. Provide comparative experience from acceding country and EU members states on implementation of specific measures defined by the National Plan for Accession.

#### B. International legal assistance in criminal matters

1. Drafting and adoption of the changes and amendments to the Law on mutual legal

#### assistance in criminal matters

- 2. Creation, printing and distribution of the Collection of the existing legal documents, which serve as a basis for the provision of international legal assistance in criminal matters
- 3. Development of training curriculum and organization of trainings on international legal assistance in criminal matters and provision of expertise for this purpose.

# C. Fighting against corruption through the development of integrity plans

- 1. Forming of Working groups for creation of the integrity plans
- 2. Drafting of the risk analysis and integrity plans for their implementation
- 3. Appointment of an integrity manager (a person to be appointed in each institution, accountable for this matter)
