Subject: Implementation of the UN Joint programme on "Promoting social equality in the Gobi-areas of south Mongolia by fostering human security with integrated and prevention approaches"

I am delighted to inform you that the UN Agencies (UNDP, UNICEF, UNFPA and WHO) in Mongolia will collaborate with the Government of Mongolia to improve human security of the vulnerable populations affected by both serious poverty and climate change in South Mongolia (6 soums in Govi-Altai, Bayanhongor, and Omno Govi) through provision of education, primary health care, water governance and income generation opportunity.

Official approval for the programme was received from the UN Human Security Trust Fund in New York on 12 April 2010. The project implementation period is for 3 years and the total cost amounts to USD 2, 703,679. The main goal of the project is to alleviate social inequality of the most neglected and vulnerable populations affected by both serious poverty and climate change in Southern Mongolia (the Gobi-areas), in order to enhance their human security with integrated, multi-sectoral and preventative measures.

The Joint Programme shall be implemented through the related ministries in following thematic areas;

- To increase access to safe drinking water and build capacity of service providers.
- To improve the quality of education through development of rights-based Child-Friendly Schools.
- To enhance access and quality of people-centered Primary Health Care.
- To provide target communities with income generation and
- . To promote the concept of Human Security in Mongolia.
