THE GOVERNMENT OF CANADA (hereinafter referred to as "Canada") herein represented by the Minister of International Cooperation, acting through the Canadian International Development Agency (hereinafter referred to as "CIDA"):

And

THE UNITED NATIONS DEVELOPMENT PROGRAMME (hereinafter referred to as "UNDP")

WHEREAS Canada wishes to make a contribution to UNDP as part of CIDA's program of development assistance to Mozambique;

WHEREAS Canada, acting through CIDA, has agreed, to participate in the Capacity Building to the National Institute for Demining Project (hereinafter "the Project"):

WHEREAS CIDA has accordingly informed UNDP of its desire to contribute funds to the Project up to March 31st, 2003.

AND WHEREAS the purpose of this Agreement between CIDA and UNDP is to set out the terms and conditions concerning the management of CIDA's contribution and the implementation of the Project.

NOW THEREFORE, CIDA and UNDP agree as follows:

ARTICLE 1

Contribution

CIDA hereby appoints UNDP as Administrator of a contribution of funds for the purpose of the Project described in Annex "A" in a total amount not to exceed one million, five hundred and forty-five thousand Canadian dollars (CDN \$ 1,545,000) (hereinafter "the Contribution"), for the Project in the following

- a) Upon signing this Agreement, UNDP shall provide CIDA with the request for an advance not exceeding five hundred thousand Canadian dollars (CDN \$ 500,000).
- b) CIDA shall provide a second advance of up to five hundred thousand Canadian dollars (CDN \$500,000) upon receipt of a request from UNDP.

- d) CIDA shall make further accountable advances to the Organization, on a quarterly or more frequent basis, upon acceptance by CIDA of a detailed budget forecast covering the next three (3) months of the Project and upon receipt of the relevant financial report(s) provided
- e) Quarterly forecasts should only cover activities that will be undertaken on a specific three month period and reflect the realistic needs of the project.
- No more than two advances may remain outstanding at any given point in time. The amount of the advances shall be based upon the original budget, as updated, to reflect known circumstances as of the date of the request for the advances. Any underutilization of previous advances shall be reconciled by adjustments in the amount of subsequent
- g) At the end of the Project, the Organization shall submit to CIDA a final report including a detailed summary of all the expenses incurred. Any amounts advanced or paid to the Organization in excess of such incurred expenses shall be immediately reimbursed to the Receiver General of Canada.
- h) Before the end of January of every calendar year of the Project, UNDP shall provide CIDA with an estimated forecast of the CIDA Contribution for the coming fiscal year beginning April 1st in each year.
- All financial accounts and statements with respect to the Contribution and the Project shall be sent to CIDA at the address indicated in Article VIII and shall indicate the following codes:

- Any identifiable interest earned by UNDP on CIDA advance payments shall be reported to CIDA and shall be returned to the Project In accordance with the UNDP procedures.
- k) For the purpose of this Article "identifiable interest" means the interest earned by UNDP on all CIDA payments when, due to changing circumstances, these payments or balance thereof are no longer required to meet the immediate cash flow requirements of the Project and have been invested.

Article II

Purpose and Use of the Contribution

The Contribution shall be received and utilized by UNDP to meet the costs of the Project as outlined in Annex "A".

The Contribution and the activities financed therefrom shall be administered by UNDP in accordance with the applicable UNDP regulations, rules and directives.

UNDP shall establish and submit separate ledger accounting and financial reports to CIDA and records for the Project reflecting expenditures incurred in respect to the Project.

UNDP shall return to the Receiver General for Canada, through CIDA any undisbursed or unaccounted portion of the Contribution on the date of expiration of the Contribution Agreement.

<u>ARTICLE III</u>

Responsibility for the Project

Responsibility and accountability for the Project shall rest with UNDP. UNDP shall be responsible for entering into such framework arrangements with other donors as are necessary to ensure the implementation of the Project.

UNDP shall have the responsibility for the supervision of the Project and shall keep CIDA informed of the progress of the Project providing to CIDA reports of activities and outputs/outcomes.

UNDP shall exercise the same care in the discharge of its functions under this Agreement as it exercises with respect to the administration and management of its own affairs.

UNDP shall ensure that the Canadian Contribution will be utilized exclusively for the Project and will be administered and utilized in conformity with the objectives of the Project.

ARTICLE IV

Auditing Procedures

UNDP shall:

- a) maintain separate records and ledger accounts in respect of the Contribution funds in the Account and those disbursed by UNDP pursuant to the provision of this Agreement.
- b) cause such accounts and records to be audited by CIDA or it's representative and certified by UNDP's external auditors at the completion of the Project.
