



**Amendment No. 2 to the UN Agency to UN Agency Contribution Agreement  
between  
The United Nations Office on Drugs and Crime (UNODC)  
and  
The United Nations Development Programme (UNDP)**

The United Nations Office on Drugs and Crime (hereinafter referred to as “UNODC”) and the United Nations Development Programme (hereinafter referred to as “UNDP”) have agreed to amend the UN Agency to UN Agency Contribution Agreement concluded between them in April 2013 and amended in December 2013 on support to the implementation of Outcome 3 of the project NGAX60 – Support to Anti-Corruption in Nigeria, in line with UN standards and norms (hereinafter referred to as ‘the Agreement’), as follows:

1. The duration of the Agreement in Section A (Summary of Activities) will be extended until *31 December 2015*.
2. Contribution amount in Section A (Summary of Activities) will be increased by *USDS\$ 1,641,213.79* to total of *USDS\$1,962,394.48*.
3. Expected outcome in Section A (Summary of Activities) will be amended as follows: Successful implementation of Project Activities for years 2013-2015.
4. Work plan for year 2015 will be added in the list of Annexes in Section A (Summary of Activities).
5. The total budget for the Activities in Section B (Budget) is amended to read:

*The total budget of the Activities is US\$1,962,394.48, as more fully described below.*

6. The budget table in Section B (Budget) is amended as follows:

Upon issuance of allocation to UNDP


