Highlights from discussions:

A. Brainstorming on Terms of Reference

- Conflict of Interest Clause: The proposition that the CSO Advisory Committee may not discuss or make input into the grant scheme as members may be potential beneficiaries was unanimously agreed to by the members.
- Mode of Operation: After extensive discussions, it was agreed that the committee will meet three times a year and not twice as proposed by UNDP. This is to ensure that it is not out of touch with project implementation.
- Suggested Members: It was agreed that for stronger gender representation and diversity of interests, a national women's group, another faith organisation and a professional/business organisation will be invited to join the CSO Advisory Committee. The group agreed that the membership should not exceed 25 for easy management. Membership was agreed to be on organisational levels, but with consistent representation by individuals. When unavailable, the organisation could ask some else to represent them.
- Secretariat: UNDP was chosen to continue functioning as the secretariat of the committee for consistency.
- B. Choosing of Chairperson and Alternate: The Terms of Reference for the Chairperson and

Alternate Chairperson are facilitating the Committee meetings; coordinating activities of the committee; in collaboration with UNDP, determine the agenda and specific meeting dates and represent non-state actors on the larger Project Management Committee, giving feedback to the CSO Advisory Committee. The Alternate will act in the absence of the Chairperson. Only networks were deemed eligible for the positions, because the criteria for CSO membership of the Project Management Committee (PMC) were CSO Networks. After an election process, the Committee choose Olanrewaju Suraju of the Civil Society Network against Corruption (CSNAC) as the Chair and Faith Nwadishi of Publish What You Pay (PWYP) as the Alternate Chair.

C. <u>Determination of Next Meeting's Timing and Agenda</u>: It was agreed that the next meeting period was June and the agenda was to be decided on by the Chair and UNDP.

D. Next Steps:

- 1. Prepare minutes of circulate for feedback and inputs before the minutes are finalized.
- 2. Finalize TOR and share with new inputs.
- 3. Invite new members to the group.
