Implementation Letter 5¹ 3-month Extension to Phase 1

Unofficial Summary:

This letter extends Phase 1 by three months while the Technical Review Panel reviews the "Phase 2 Request." The updated Performance Framework and Summary Budget for Years 1&2, which contain targets and budget for this extension period, are also attached.

Dear Mr Frode Mauring,

We are writing this letter to provide you with a 3-month extension to your Round 7 HIV/AIDS Grant Agreement. The Phase 1 Ending Date is changing from 28 February 2011 to 31 May 2011.

The purpose of this extension is to ensure that Program activities continue while the Phase 2 decision is being made. You may continue to use unspent Phase 1 funds during the extension term in accordance with the approved budget attached to this letter, but no additional funding is being committed at this time.

This extension does not mean that Phase 2 of the Program has been approved. If the Global Fund decides to commit funding for Phase 2 of the Program, the overall five year term of the Grant Agreement will remain the same. The Proposal Completion Date remains 30 November 2013.
