Leveling Off Meeting with the Responsible Partners (May 24, 2012)

The Climate Change Commission called on the mandated agencies as well as the academic institutions identified in the project document. This is primarily to orient the RPs of the project components and target outputs. The timeline for the inception workshop and discussion on the implementation framework of the project were also discussed. The copy of the highlight of meeting is attached as one of the Annexes.

Presentation to the Regional Land Use Committee (Region 10) Meeting (July 12, 2012)

The Climate Change Commission, through its Executive Director, Secretary Lucille Sering, presented the salient features of the Project Climate Twin Phoenix to the RLUC-X. For the project, the Commission was able to solicit Aus \$ 1.5 Million from the Australian Government for the implementation of the project for the period 2012-2014. With issues of duplication as there are already existing initiatives related to DRR/CCA in the region, the project will be a conceptualized programmatic intervention on DRR and CCA which is firmly rooted in scientific and replicable approaches. The meeting also served as an opportunity to present to the RLUC-X the strategic considerations for the project, the general objective, the target sites, the project components and their outputs, as well as the management/implementation arrangements. Thereafter, the RLUC-X unanimously endorsed the Project Climate Twin Phoenix through a resolution for presentation to the Regional Development Council -10 for confirmation on its 3rd Quarter Meeting on August 16, 2012.

Inception Workshop (August 23, 2012)

The Climate Change Commission organized this activity with the objective of gathering Responsible Partners to review the Project Document (ProDoc), identify sub-activities that can deliver the expected outcomes as specified in the ProDoc, and seek to find out where each agency or organization can link up with the rest of the players per project component. Forty-one (41) participants attended the activity with 22 females and 19 males from government agencies, CSOs, Academe and the Private Sector. To supplement the report, attached is the highlights of the workshop including the programme.

Regional Experts' Forum on DRRM and CCA (October 10-11, 2012)

The Regional Experts' Forum on DRRM and CCA is a joint undertaking of the Climate Change Commission and the National Economic and Development Authority, Region X as a venue to interface with the Project Climate Twin Phoenix considering that the region is currently implementing the "Enhancing Capacities on DRR/CCA Project." The main purpose of the forum is to review the Disaster Risk/Vulnerability Assessment Methodologies and Outputs by the mandated agencies and DRR/CCA experts, specifically to seek inputs from technical experts to improve methodologies and enhance DRA results, and identify possible areas of interface or areas of collaboration of the two projects in the implementation of the remaining deliverables of the "Enhancing Capacities on DRR/CCA Project." Attached in this report is the highlight of the forum conducted in Cagayan de Oro City.

Leveling Off Meeting with the Academe and LGUs in Project Sites (November 15-17, 2012)

The PMU conducted meetings in the field with representatives from the Xavier University-Ateneo de Cagayan (XU), Iligan Institute of Technology of the Mindanao State University (MSU-IIT), City Planning and Development Offices of Cagayan de Oro and Iligan to discuss partnerships and plan, among others, the initial activities including the Training of Trainers on Disaster Risk Reduction and Climate Change Adaptation (DRR/CCA) for Local Partners as part of the capacity development for partners on CCA/DRR.

Selection and Engagement of National Technical Expert for DRR/CCA Capacity Development

The National Technical Expert (NTE) on DRR/CCA Capacity Development is primarily responsible for the provision, coordination and implementation of the conduct of a *Training of Trainers on DRR/CCA for Local Partners (DRR/CCA ToT)* aimed at local academic institutions i.e. XU and MSU-IIT and key project partners such as the local government planners from the two cities. The training shall have the objective of developing a core group of trainers among the local partners who will provide technical expertise and assistance to other project stakeholders/partners at the local level in the field of DRR/CCA.

Signing of the Memorandum of Agreement with Project Partners

The CCC-CCO entered into an agreement with the National Economic and Development Authority (NEDA) Regional Office X for the establishment of the CRISP or Climate Change and Disaster Risk Information System for Planning in the region. CRISP will support the DRR/CCA mainstreaming process as well as support and enhance climate/disaster risk assessments. NEDA 10 can integrate into the CRISP all other databases and information systems it is operating, and network with critical agencies and local government units in data gathering, identifying issues/concerns on data structures and standards, and harmonizing the system in the partners' respective knowledge management systems.

On the other hand, one of the outputs of the Project is enhanced competencies of local government units in mainstreaming climate/disaster risk management into local land use and development planning and regulatory processes. The collaboration between CCC and HLURB is necessary in the formulation of Supplemental Guidelines on Mainstreaming Climate/Disaster Risks in the Comprehensive Land Use Plans with one local government unit in the Project area as case study. The collaboration also aims to enhance capacities of HLURB staff in the use of the Supplemental Guidelines.

Engagement of Video Director and Graphics Artist

The PMU availed the services of a Video Director and Graphics Artist as part of the preparations to the formal launching of the project. These artists were incharged of putting up a teaser video and lay-outs for the project logo, flyers, tarpaulins and cover designs.

Project Launching and 1st Project Board Meeting (December 11, 2012)

The Climate Change Commission, together with the United Nations Development Program (UNDP) and AusAID, formally launched Project Climate Twin Phoenix in simple ceremonies in Cagayan de Oro City attended by the members of the Project Board, various agencies of the government as Responsible Partners, local stakeholders such as the Provincial and City Local Government Units, regional government agencies, academe, civil society and the private sector. The project's first board meeting, chaired by the CCC with the UNDP as co-Chair, was held right after the launching ceremonies.

H. LESSONS LEARNED / EMERGING LESSONS

- <u>Core Group Meeting:</u> Prior to the initial stakeholders' consultation, we organized a core group meeting among key National Government Agencies handling critical sectors for implementing DRRM/CCA.
- <u>Stakeholder Consultations:</u> This involved pre-inception dialogues and an inception workshop with the Responsible Partners to gather their support, different views, and commitments on how best the project can be approached and operationalized. This provided a venue to present the project overview, key concepts on DRRM/CCA and background information on on-going projects or initiatives that helped the participants understand the relevance of the project in the region.
- <u>Complementation with other related activities:</u> The CCC, being the focal government agency in implementing other related foreign-assisted projects, helped ensure there are complementation rather than duplication of activities to maximize the assistance received by the Philippines. This was demonstrated with the conduct of a Regional Experts' Forum in partnership with NEDA to find possible areas of interface or areas of collaboration in two related projects that involve the major river basins of Cagayan de Oro and Mandulog in Northern Mindanao.
