measured at constant prices from 2008-13 averaged PhP5 trillion/year. Measured against this metric, estimated biodiversity spending of all agencies (including Official Development Assistance) is a measly 0.08% of GDP for this period. The country's national budget stood at PhP1.6 trillion for the same period, and biodiversity spending represents only 0.31% of the national budget. Biodiversity spending can be compared to the share of the Agriculture, Fishery, and Forestry Sector contribution to the GDP, primary sectors that depend on biodiversity. This sector's contribution to GDP from 2008 to 2013 is 11.0%, while the fishery sector alone contributes 2.5%. Thus, income derived from the fishery sector is roughly 31 times the current biodiversity spending. To mobilize resources for the implementation of the PBSAP, the Biodiversity Financing Initiative (BIOFIN) will contribute to closing the financing gap for the conservation and sustainable use of biological diversity by identifying, accessing, combining and sequencing sources of biodiversity funding to meet national needs. The specific objectives of the BIOFIN are to develop, test (in 31 countries) and disseminate:

- a framework for mainstreaming biodiversity into national development and sectoral planning;
- a methodology for assessing a country's biodiversity financing needs; and
- a framework for national-level biodiversity financing.

Specifically, the BIOFIN will undertake the following:

- a. policy and institutional review, the results of which were incorporated in the Philippine Biodiversity Strategy and Action Plan (PBSAP)
- b. public and private expenditure review to determine the level of biodiversity financing
- c. costing of the PBSAP and estimation of gap/surplus financing
- d. preparation of a biodiversity finance plan (BFP) to address the financing gap
- e. implementation of the finance solutions

The first four activities have been completed from 2014 to 2015, and currently, the project is finalizing the BFP and implementing the following finance solutions to increase biodiversity investments in the country:

- A. Improved Biodiversity expenditure reporting
 - Proposed biodiversity expenditure tagging system for DENR bureaus
 - Policy support towards increased biodiversity funding among other national government agencies
 - Alignment of environmental trust funds with the PBSAP

B.4 Lessons learned and ways forward

Leadership and sponsorship

Key stakeholders that need to be strategically engaged have to be identified, the stakeholder network strengthened, and continuously engaged to ensure clear communication of objectives to achieve a shared vision. This was done in Phase 1 and continued in Phase 2. The current leadership of the Biodiversity Management Bureau in the person of OIC Assistant Secretary Dir. Ricardo Calderon provides full support to the project, which has facilitated project implementation. It is also important to stress the leadership of the Project Board, who have provided excellent guidance and support to BIOFIN. Decisions in project implementation are transparent and collegial. Cong. Sato's immediate and overwhelming response to the crowdfunding campaign for the Mangyan rangers and wardens who have lost their jobs because of the pandemic is very much noted. The existence of the critically endangered tamaraws is dependent on the presence of these rangers and wardens.

Visibility

The visibility created by the crowdfunding campaign, #TogetherForTamaraws, launched this quarter significantly contributed to the near attainment of the on-going campaign's financial target. Utilizing media (traditional and social) and technology for awareness raising and resource mobilization, the campaign is an innovation tester as well as a community building and marketing instrument that involved the public in the issues with regard to conservation.

Sustainability

A year before Phase 1 was completed, BIOFIN prepared a sustainability plan to ensure the institutionalization of initiatives. One of these is the creation of the Technical Secretariat for the Implementation of the PBSAP which is seen as the body that can mainstream the BIOFIN methodology within the BMB. BIOFIN is developing an appropriate capacity-building program for this body to enable it to fully understand and appreciate the BIOFIN methodology and to implement relevant finance solutions and expand community practice. A TNA has been sent to concerned DENR personnel (park superintendents, relevant regional staff) and relevant local government technical staff and based on their results, a training design will be developed on the BIOFIN methodology. A capacity building program on private sector engagement was completed for 7 NGO partners. A similar program will also be developed for DENR. BIOFIN continues to support policy formulation to institutionalize its initiatives. Draft policies on the localization of the PBSAP including the BIOFIN methodology, private sector engagement, and integrating biodiversity

in mining activities are under review by concerned offices. BIOFIN is also exploring the possibility of the Natural Resources Development Corporation as the fund holder of the revenues that will be generated by the mobile game application called Animal Town.

Cohesion and relationship management

Good relationship management which includes constant communication with and feedback from key stakeholders is important. BIOFIN will continue to provide various opportunities to exchange ideas and articulate project goals and objectives to stakeholders. These venues help ensure transparent communication and help develop trust among stakeholders. When people are aware of the relevance of the project for them and their institutions and of what their specific contribution is, they stay engaged. However, there are times that it is difficult to keep stakeholders aligned behind the overall goal and "backdoor diplomacy" and informal consultations are needed to keep them onboard. This quarter, BIOFIN continues to nurture its relationships with its partners such as the private sector (G-Cash Philippine National Bank, ADEC Innovations), its government and LGU partners (DENR bureaus, DENR regional offices CALABARZON, 6, 7, 9, 12, Tamaraw Conservation Program, DSWD, DOE, DILG, DPWH, DA, Negros Oriental, Negros Occidental), NGOs (Philippine Biodiversity Conservation Foundation, Inc.; Eco Explorations; Mindoro Biodiversity Conservation Foundation, Inc.) and legislative partner (Office of Congresswoman Josephine Ramirez-Sato) to implement its respective finance solutions.
