2. Brief Opening Remarks by Chair of Pre-PAC

• The Pre-PAC Chair thanked the attendance of the members for attending the Pre-PAC meeting on a very short notice. The Pre-PAC meeting was called earlier to ensure UNDP gets the Project Document and appraisal processes completed on time as agreed by the Government of Palau to ensure UNDP gets the funds under the Cost Sharing Agreement. The Chair outlined that the process of the Pre-PAC will include getting the feedback from the Pre-PAC meeting and following which the Project Developer and colleagues from IRMU will meet straight after to look at changes and edits to be done to the document. This was generally agreed by the Pre-PAC members.

3. Comments during General Discussion

- Brief overview of the comments that came through and adressed prior to the Pre-PAC Project Document was shared with Pre-PAC members was explained by the Project Developer.
- Service delivery thinking at the local level was discussed and how the Project will ensure strengthening of service delivery at local level. It was noted that most of the service delivery is undertaken by the Central Government and that in terms of decentralisation this is something which is not obviously widely seen as a possibility for this project.

- It was discussed that Project Document will need to strengthen the Theory of Change. It also needs to strengthen the narrative on Partnerships to include details on how other UNDP projects in Palau can potentially contribute to the objectives of this project; e.g. Palau CB2 which mirrors the strategy and purpose of this Project in the environment sector. Also to include a line on how the Project will be working in the area of transparency and accountability with the UNPRAC project in area of Anti-Corruption.
- It was recommended that UNDP experiences in other countries with regards to the use of the Local Governance Diagnostics tool, and how it can benefit Palau in terms of strengthening local governance, be added to the narrative. This should be added in the Strategy section.
- The Project will also need to see how the activity around "Development of a monitoring framework" can be reviewed and contextualised models developed for Palau during implementation.
- Consistency throughout the project with references to the number of states to be included in the project.
- The meeting also recommended a review of the SESP after first year of implementation to ensure identified social and environmental issues are dealt with during project implementation.
- The Project Budget also needs to be reviewed to ensure total amount is correct, and to match with project entry/set up in ATLAS.
