A. SUMMARY OF ACTIVITIES

UNDP and the European Union (EU), UN Environment will take responsibility for timely and successful delivery of Project Output 1.3, *Governance of transboundary water management improved*, and Output 3.3, *Capacities for transboundary water*

management improved.

Expected outcome:

The project is intended to address the drivers of conflict and instability, irregular migration and displacement in the cross-border areas of the Horn of Africa through improved cross-border coordination and cooperation. The specific objectives of the Project are:



- 1. To strengthen regional policy frameworks, structures and protocols for cross-border cooperation between national and local Governments, the private sector, civil society and international technical and financial partners in development;
- 2. Capacities of communities, local governments and civil society to fully engage in processes for development planning and results are built;
- 3. To ensure effective cooperation and coordination, monitoring and evaluation of crossborder initiatives including involvement of relevant national and regional actors in these processes

The project will be implemented by UNDP in collaboration with UN Environment. UNDP and UN Environment will work in partnership with Intergovernmental Authority on Development ("IGAD"). The project is funded by the European Union, with co-financing contributions from UNDP and UN Environment.

The Recipient Agency will be fully responsible for administering the Contribution in accordance with its financial regulations, rules, policies and procedures, and administrative instructions, and carrying out the Activities efficiently and effectively, in accordance with the following terms and conditions.

B. BACKGROUND

On 21st February 2018 the Donor Agreement was signed between the European Union (the "Donor"), and the Contributing Agency.

Further to the Donor Agreement, the UNDP is awarded financing for the Project, Support to the Effective Cooperation and Coordination of Cross-border Initiatives in Southwest Ethiopia-Northwest Kenya, Marsabit-Borana & Dawa, and Kenya-Somalia-Ethiopia (hereinafter called "the Project") as defined in the Donor Agreement, on the terms and conditions set out in the Donor Agreement, including its attachments as specified above.

The Activities hereunder are those parts of the Project for which the Recipient Agency is responsible under the Donor Agreement and this Contribution Agreement (with respect to the Activities).

C. <u>USE OF FUNDS AND ACCOUNTABILITY; INDEMNIFICATION; MATERIAL TERMS</u>

The Recipient Agency will be fully responsible for administering the Contribution in accordance with its financial regulations, rules, policies and procedures, and administrative instructions, and carrying out the Activities efficiently and effectively.

The Recipient Agency shall have full programmatic and financial accountability for the use of the Contribution and for the results of the Activities. In this regard, in addition to and notwithstanding the terms hereof, the Recipient Agency agrees to implement and comply, and ensure compliance, with all relevant provisions and requirements under the Donor Agreement imposed on UNDP that



relate to funding recipients, attached hereto and made an integral part hereof as if applicable to Recipient Agency *mutatis mutandis*, provided, however, that all reporting required of UNDP under the Donor Agreement shall be provided by Recipient Agency to UNDP in accordance with Section F hereof, in adequate time in order for UNDP to review and consolidate that reporting for overall reporting to the Donor under the Donor Agreement.

Without limiting the foregoing, in case the Donor considers any expenses incurred, payments made or activities undertaken with respect to the Activities implemented by the Recipient Agency further to the Project, financed under the aforementioned Donor Agreement, ineligible, the Recipient Agency assumes full financial responsibility for these expenses, payment or activities, and the consequences thereof, in accordance with the terms of the Donor Agreement. The Recipient Agency shall seek to resolve the issue directly with the Donor, keeping UNDP fully informed; if for any reason under this agreement the Donor requires the reimbursement of funds allocated to the Recipient Agency, UNDP shall repay the Donor the amounts requested in accordance with the Donor Agreement and the Recipient Agency agrees to reimburse fully UNDP for these amounts.

D. <u>BUDGET</u> The total budget for the Activities is \$2,719,726, in USD, as more fully described below.

The Contributing Agency will not be responsible for any financial commitment or expenditure made by the Recipient Agency that exceeds the budget for the Activities. The Recipient Agency will promptly advise the Contributing Agency any time when the Recipient Agency is aware that the budget to carry out these Activities is insufficient to fully implement the Activities in the manner set out in the present Agreement, including its Annex(es). The Contributing Agency will have no obligation to provide the Recipient Agency with any funds or to make any reimbursement for expenses incurred in excess of the total budget as set forth herein.

E. COSTS RECOVERY

It is agreed and understood that the pass-through services performed by UNDP further to the Donor Agreement and this Contribution Agreement is equivalent to 1% of the Contribution. This fee shall be retained by the Contributing Agency from the payments to the Recipient Agency as part of its fee general management services (GMS) of the Contribution Amount for the pass-through services performed by the Contributing Agency further to the Donor Agreement and this Contribution Agreement. This amount should be funded by the Recipient Agency from its GMS earned, and cannot be recharged to the Activities.



F. REPORTING

Narrative reporting:

The Recipient Agency will provide the Contributing Agency with a narrative report on the progress of the Activities on a regular basis, to meet all requirements of the Contributing Agency outlined in the Donor Agreement and its attachments. These will include:

- 1. An Inception Phase report, at least one month prior to the deadline for submission of the full UNDP Inception report to the EU (ie, by 21st July 2018);
- 2. Quarterly updates on indicators & bi-annual Visibility and Communication ("V&C") reports, to a schedule to be discussed and agreed with UNDP Project management;
- 3. Annual narrative and financial progress reports, from 1st March to 28th February each year of project implementation;
- 4. A Final Report for the Project by end April 2021.

Financial Reporting:

The Recipient Agency will provide the Contributing Agency with the following financial reports, prepared in accordance with the Recipient Agency's financial regulations, rules, policies, procedures, and administrative instructions:

- 1. Annual financial reports, from 1st March to 28th February each year of project implementation;
- 2. A financial Final Report of all Project expenditure by end April 2021.

G. CONTRIBUTIONS

The total amounts paid by the Contributing Agency shall match the total budget amount less 1% GMS as per Clause C above, "Cost Recovery". For Activities less than one year in duration the Contribution will be paid to the Recipient Agency prior to the commencement of Activities. For multi-year Activities the Contribution will be paid in instalments according to the following schedule.

J. AMENDMENTS

The present Agreement, including its Annex(es), may be modified or amended only by written agreement between the two Agencies.

K. COMPLETION OF THE ACTIVITIES

The Recipient Agency will notify the Contributing Agency when all Activities have been completed.

The Recipient Agency will continue to hold any part of the Contribution that is unutilized at completion of the Activities until all commitments and liabilities incurred in the carrying out of the Activities have been satisfied and all arrangements associated with the Activities have been brought to an orderly conclusion.

L. <u>TERMINATION OF THIS AGREEMENT</u>

This Agreement will expire upon satisfaction of all commitments and liabilities incurred in carrying out the Activities and the orderly conclusion of all arrangements associated with the Activities.

This Agreement may be terminated earlier by either Agency at any time by written notice to the other. Termination will be effective thirty (30) days after receipt of the notice. In the event of termination under this paragraph, the two Agencies will cooperate to ensure completion of the Activities, satisfaction of all commitments and liabilities, and the orderly conclusion of all arrangements associated with the Activities.

M. REFUNDS OF UNSPENT BALANCES

Upon termination of this Agreement and following the submission of the final financial report, any unspent balance from the Contribution will be returned to the Contributing Agency, unless otherwise agreed in writing by the two Agencies.

N. <u>SETTLEMENT OF DISPUTES</u>

The two Agencies will use their best efforts to promptly settle through direct negotiations any dispute, controversy or claim arising out of or in connection with this Agreement or any breach thereof. Any such dispute, controversy or claim which is not settled within sixty (60) days from the date either party has notified the other party of the nature of the dispute, controversy or claim and of the measures which should be taken to rectify it, will be resolved through consultation between the Executive Heads of each of the Agencies.

O. ENTRY INTO FORCE AND VALIDITY

This Agreement will enter into force upon its signature by the authorized representatives of the Parties and remain in force until it expires or is earlier terminated in accordance with Section L above.
