I am pleased to inform you that I am endorsing the project proposal entitled Sudan: Implementing NAPA Priority Interventions to Build Resilience in the Agriculture and Water Sectors to the Adverse Impacts of Climate Change, for \$3,300,000 in financing from the Least Developed Countries Fund (LDCF).
