The compact we are offering is this: your UN team tests innovations and we at the UNDG at headquarters help to remove bottlenecks, support scaling of agency innovations to the UN system and integrate what you demonstrate and prove into UNDG policies and guidance.

FUNDING

Your UNCT has been allocated **USD 30,000 USD** for this proposal to be spent in full by **June 2019**. We acknowledge that the proposal submitted by your team was planned at a larger scale, but the proposals this year were highly competitive. Fundraising efforts are currently under way, and more funds may become available in September or early in 2019.

The first installment (50%) of the funding will be available to you in the early months. Please note that the remainder of the funds will only be made available if the first half has been disbursed or fully committed by the first week of December 2018. If no expenditure or commitments have been made based on UNDP procedure in Atlas, the second part of the funding will be reallocated to other countries with innovation momentum!

Please set up a project in Atlas with the following fund code 68080 and donor code is 00231. Please do not co-mingle these funds with other fund codes.

WORKING OUT LOUD

As part of the policy-to-practice feedback loop, we look forward to advising and learning from your innovations. Your UN DOCO focal point for this exercise are Maria Blanco (maria.blanco@undg.org).

Here's what we expect from you and will deliver as back up support:

- Peer-to-peer sessions to pitch and refine your innovation, organized by DOCO and bringing in UN agency innovation focal points where needed
- Participation where funding permits in an UN Innovations Bootcamp to be organized in the third quarter 2018

- Presentations during webinars related to your area of innovation
- Blogging and editorial support to explain your work publicly

When it comes to reporting requirements for your innovations, the focus is on 'working out loud'. This means that we do not request detailed project reports for an internal audience. We ask that your team help the UNDG promote transparency and crowdsource ideas by sharing your work on our [Silofighters Blog](#).

- **September 2018:** Submit one draft blog which explains to a public audience what your innovations are, even in the early planning stages. This should call for participation from experts and partners to improve the innovation you are working on.
- **March 2019:** Tell the part II story of your blog – moving beyond your initial plans to explain how it all worked out in practice. This should be based on personalized descriptions of what your work is and how it has advanced the field of knowledge in your innovation area.

- Test business innovations and new technologies to manage UN operations
