It also tackles the political and civil rights as it focuses in inclusion of youth and women (in particular young girls) in decision making processes and in structuring in forums to represent their voice. Finally, through its entrepreneurship and mentorship components contributes to some extent to the economic right of the targeted groups.

The Project aims to work with young women. 50 percentage of participants will be women of which 10% will be single mothers. Women are recognized for their peace building efforts during the tensions in Solomon Islands history and this project will ensure women continue to trained and ready to involve in peace building efforts at the community levels when the need arises.


