B. PROPOSED PROJECT PREPARATION ACTIVITIES (\$)

Describe the PPG activities and justifications:

The proposed PPG activities are enumerated below. The outputs of these activities will be a UNDP-GEF compliant, full-sized project document and CEO Endorsement document for submission to the LDCF.

- Through consultations with government, non-government and community stakeholders, identify the final project sites (6) from the preliminary list identified in the PIF, based on a criteria that include the vulnerabilities of the water sector to climate change impacts;
- Conduct rapid assessments and review secondary information to characterize every project site in biophysical, socioeconomic and demographic (including gender) terms;
- Assess (preliminary) all available sources of water supply focusing on quantity and quality and their vulnerabilities to climate change impacts;
- Characterize sanitation practices in each site and their impacts on water resources;
- Undertake intensive community consultations regarding their water and sanitation priorities in the context of climate change and to mobilize support for the project;
- Identify and assess potential CC adaptation activities in the water and sanitation sector that will be financed by LDCF and describing rationale and projected impacts in improving community resilience:
- Identify, assess and confirm development baseline activities (government, private sector, various donor agencies, NGOs and church-based organizations, others) in the water and sanitation sectors in the entire country and in the proposed project sites, and prepare an assessment report about relevant development and disaster management projects, investment programmes and capacity building activities;
- Review existing policy and regulatory framework relevant for integrated water resources manangement and community-based disaster risk reduction, with particular emphasis on current climate-related impacts and threats:
- Prepare the Strategic Results Framework and a Monitoring and Evaluation (M&E) system with quantifiable and verifiable impact indicators. These indicators, which will specifically address adaptation impacts, will be based on guidance by the LDCF results framework for adaptation projects. The indicators will be connected to a monitoring and evaluation plan, which will set out how and by whom these indicators will be measured and which way verification data will be collected by the project.
- Define the implementation. execution and coordination arrangements for the project with detailed roles and responsibilities of government entities, UNDP and partnering NGOs and a timeline for project

implementation;

- Prepare a stakeholder involvement plan for the preparation and implementation phase of the project, with a clear focus on community involvement and participation;
- Liaise with government and secure letters confirming co-financing commitments from all partners;
