POLICE in Gizo, Western Province (WP) have recovered cash of \$243,100 and some personal properties owned by Pacific Crest Company at their operation on Ranogga Island on 27 February 2018.

Police have arrested a 33-year-old man allegedly involved in stealing the cash and personal properties.

"I want to thank the people who helped the police in their investigation which led to the successful recovery of the large amount of money and the valuable properties," says PPC Lenialu.

Provincial Police Commander (PPC), Western Province, Chief Superintendent Mathias Lenialusays, "a man allegedly involved in the incident was arrested by my Investigators and formally charged with three counts of Simple Larceny and released on bail to appear in the Gizo Magistrate Court on 26 March 2018."

Commissioner Juanita
Matanga says hunting
down accused persons
who are under warrant of
arrest in other countries
can be done depending on
the case.

Ms Matanga made theresponse when asked if the Royal Solomon Islands Police Force can use its connections through the INTERPOL to hunt down accused persons who went overseas and never return to the country to face their charges.

"We have partnerships with other law enforcement agencies," Ms Matanga said.

She also added they also have other mechanisms but it depend very much on the case. "We also look at the cost of it as well.

"Is it really cost effective for us to do that?

"These are the things we have to consider."

"But we will work closely with court to ensure we support the court's work."

She also added that the warrant of arrest issued will remain to be effective until the accused person returns to the country.

"That is when we will deal with the warrant of issue," Ms Matanga said.

Ms Matanga's comments came following the disappearance of an Asian, Ting Kwong Hing, almost a year after he was given leave to travel to Australia on 6 July last year.

He was supposed to return to the country on 15 July last year but then never did so.

This resulted in a warrant of arrest being issued for him.

A copy of the warrant of arrest was given to the Immigration Department in the hope that they would execute it when Hing arrived from abroad.

Michael Pitakaka of Michael Pitakaka Law Chamber, who used to represent Hing, had already withdrew his legal representation.

This was because Hing left without paying his legal bills and without giving any instructions to his lawyer to continue represent

Hing was accused of illegally setting up a casino, Cyber King at the Crossroad, Henderson but he was ordered to close its doors on 27 April 2016, just days after

This followed a stop notice served to them by the Members of the Gaming and Lottery Board for allegedly operating unlawfully without commercial gaming permit issued by the Gaming and Lotteries

Hing's matter will be brought back to the court again on March 28, for the last review of his warrant of arrest.

Principal Magistrate Fatima Taeburi was of the view that if nothing hap-pened by then, the matter should be withdrawn.
