Objective of the Workshop:

Purpose/Objective of Mission:

- To travel to selected communities in North Malaita:
 - o Manure
 - o Fo'ondo
 - o Rameau
 - o Beth (Sulione)
 - o Silolo
- To discuss with youth and community leaders the engagement of youths from these communities in the peacebuilding and livelihood training to be delivered by Coconut Technology Centre.
- To identify up to 50 youths from these communities to participate in the peacebuilding and livelihood training.

Mission Outcomes:

- List of names and contact details of youths from these communities who will participate in the peacebuilding and livelihood training
- Profile of selected marginalized youths from these communities.

Lessons Learned:

- Such mission ensures to engage community leaders and representatives, however it occurred during the Easter Season in which most members of the selected communities were not available due to competing priorities. At the time of the visit most members of the communities travelled to Parish Centers and stayed there for the duration of the Easter Season to celebrate masses, conventions and other religious activities and were not available for consultations and dialogue, leaving few elders and leaders in the communities. Easter sporting events also attract youths resulting in most youths attending with few youths remained in the communities for consultations and dialogue.
- The skill gaps that exist between male youths and female youths may have resulted from a number of factors including, limited ability of female youths in these communities to travel for training to Honiara, and social factors that put pressure on female youths to enter training for traditional occupations instead of training that is geared to new demands of the labor market such as the DME training. Male youths and female youth needs with regard to their economic participation also differ.



Female youths require specific support to address the fact that they are responsible for the majority of domestic work when interventions for skills development and training are created. As such community leaders in these selected communities may be reluctant to send female youths to participate in the planned skill development and training.

Best Practices Learned

Training initiatives have been mostly targeted at the formal sector of the economy, while vast numbers of youths in these selected communities live in poverty and engage in anti — social behaviors and some economic activity in the informal sector. Therefore, to identify marginalized youths in these communities needs understanding of their needs and situation and linking this analysis to the livelihood system seems like not an easy task. As such understanding the context in which these communities go about their daily lives is essential towards linking this analysis to this panned livelihood training. Therefore, selecting marginalized youths from these communities to attend such training was successfully staged due to the style of community approach and engagement of community leaders.
