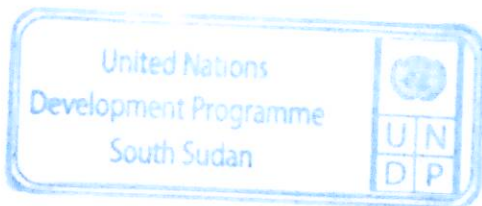

2. **Background:**

At the South Sudan Humanitarian Fund (SSHf) Advisory Board meeting on 23 November 2018 the 2019 First standard allocation process was triggered. The collective priorities and requirements developed by the Inter-Cluster Working Group (ICWG) were endorsed by the Advisory Board at the cluster defence meeting held on 19 December 2018, establishing a total amount of US\$34.5 million for project budgets, after which the call for project proposals was launched.

Humanitarian partners then submitted a total of 276 project proposals for SSHf funding consideration. After rigorous strategic reviews under the auspices of the respective clusters, a portfolio of 166 proposals was recommended for the Humanitarian Coordinator's (HC) endorsement in principle.

Following the HC's endorsement of the portfolio on 3 February 2019, partners further refined the proposals in line with feedback from the strategic reviews and with additional guidance from the respective clusters and the SSHf Technical Secretariat.

The second batch of project proposals – NGOs projects with a total value of US\$30,423,861.47, including \$28,151,995.56 in project budgets and \$2,271,865.91 in UNDP PSC costs – is now ready for HC's final approval. Enclosed is the allocation letter to UNDP, as the Managing Agent for NGO projects, and three corresponding FTRs for signature. Following signature, UNDP will countersign the allocation letter to enable the transfer of funds from the Multi-Partner Trust Fund Office in New York.

Paperwork for the last batch of NGO project proposals to complete the allocation will follow.
