

Arrangement based on a General Arrangement

Arrangement between the Minister for Foreign Trade and Development Cooperation of the Kingdom of the Netherlands, hereinafter referred to as the Minister,

and

United Nations Development Programme, hereinafter referred to as UNDP;

With reference to the General Arrangement concluded on 17 August 2005 between the Minister for Foreign Trade and Development Cooperation of the Kingdom of the Netherlands, and the United Nations Development Programme hereinafter referred to as UNDP;

Whereas the Minister has decided to support the project Youth Employment and Empowerment through Private Sector and Value Chain Development 2018-2022, application no. 4000002057, agreement no. 6003382 up to a maximum of USD 9,424,953;

Whereas UNDP is prepared to accept the support under the conditions of the General Arrangement;

The Minister and UNDP have come to the following Arrangement:

The support will be provided for the period from 01 December 2018 to 31 December 2022.

The terms of the General Arrangement will apply to this Arrangement, unless otherwise stipulated herein. In addition the following will apply:

- The Minister will deposit his/her contribution in the UNDP Contributions Account number 36349562 (USD) held at Citibank, N.A, 111 Wall Street New York, NY 10043 (SWIFT Code CITIUS33; ABA/ACH Routing Number: 021000089 in accordance with the payment schedule as follows:
- The first payment of USD 2,000,000 will be made upon receipt of the signed Arrangement;
- Any subsequent payments will be made every 12 months on the basis of a request for payment (including a liquidity forecast for the next period);
- It is understood that the above payment schedule is based on the planned implementation schedule and that it may be adjusted, on the basis of disbursement rates as indicated in the financial statements, to reflect actual progress with the project.
- The contribution is made under the condition that the Netherlands Parliament appropriates sufficient funds.

Annex provisions concerning non-compliance, anti-corruption and/or improper behaviour

· Non-compliance paragraph

The Minister may halt payment or demand repayment of all or part of the funds transferred if contractual and/or reporting and accounting obligations are not met, or if it emerges, either from the reports referred to or from some other source, that the funds are not being used or have not been used for the implementation of the project as approved, or if alternative funding proves to have been obtained (either wholly or in part), thus giving rise to double financing.

Anti-corruption paragraph

UNDP will require that its staff and consultants deployed on projects or programmes financed by the Minister will not offer to third parties or seek or accept from or be promised by third parties, for themselves or for any other party, any gift, remuneration, compensation or benefit of any kind whatsoever, which could be interpreted as an illegal or corrupt practice.

· Illegal practices and/or improper behaviour

UNDP will take appropriate measures to prevent illegal practices and/or improper behaviour (such as fraud, violation of the fundamental principles of procurement rules, harassment, sexual harassment, sexual exploitation and abuse, other forms of misbehaviour and/or any irregularity) in connection with the implementation of the project. In the event that UNDP determines that there are credible allegations of illegal practice and/or improper behaviour, UNDP will take swift and appropriate action to stop, investigate and prosecute in accordance with applicable organizational regulations and applicable law any person suspected of such practice.

UNDP will promptly inform the Minister of any instances of illegal practice and/or improper behaviour as referred to in this paragraph. The notice will indicate the nature of the misconduct and when applicable the financial amount involved and will include the action which will be taken by UNDP. The notice will be given in writing and delivered to the Minister's point of contact, Richard Aludra (richard.aludra@minbuza.nl). On receipt of the notice, the Minister may suspend the contribution to the project/programme, if the procedures are not being followed correctly and transparently.
