Dear Jose.

I took a while to respond because I wanted to sufficiently consult on your enquiry within the SGP team. As I understand it, we can only for sure start up an SGP programme when countries make formal requests to join the SGP global programme and funds are made available in the operational phase. If this is received, then a new country programme can be started only if the SGP Steering Committee has decided positively on the application, and especially having discussed on the ways of providing the resources needed for it.

In the OP4/OP5 global project document for SGP, a few countries in Africa were listed among the new country programmes that were to be started. However, due to the fact that the necessary applications were not received and also because around the mid of 2013, funding shortage was experienced which led to the GEF CEO and the SGP Steering committee recommending that no start up for new country programmes could proceed. The new proposed country programmes in OP5 were kept on hold. Sao Tome & Principe was not alone in this unfortunate situation but other countries like Sudan were equally affected.

Similarly, as per the recently GEF Council approved SGP paper on implementation of the OP6 programme, there will be no new country programmes expected unless additional resources are available. In this context, it is important to find out what is the STAR allocation of Sao Tome & Principe in OP6? If it is more than \$15 million, perhaps the STAR funds could be requested to support a ST&P SGP country programme.

Therefore, if Sao Tome & Principe wishes to have a CSO' led programme like that of GEF SGP, then it actually can proceed with setting up an SGP-like country programme by developing the FSP PIF for such, using country STAR funds. ST&P can use the SGP Operational Guidelines and we can help it set up the system even though its funding is through a stand-alone FSP just like the upgraded country programmes. SGP in consultations with UNDP CO can, perhaps, find a way that while the ST&P country programmes may strictly not be under the global SGP, it can be considered, and given guidance, as part of an expanded family of SGP country programmes as long as they adopt fully the SGP Operational Guidelines.

However, if the above are not tenable, ST&P may apply to the SGP programme during the upcoming GEF 7 expected to be rolled in by 2019. The preparation for this should start as early as possible by doing the following:

Application by the Government of ST&P through the UNDP Country Office

A letter from the UNDP Country Office to SGP Global Steering committee forwarding and recommending the applications and making a case for the SGP programme.

Thank you very much and I hope the explanations and options provided for a way forward may be practical for ST&P.
