UNOFFICIAL SUMMARY:

This implementation letter changes the Program Starting Date; the Program Ending Date; and the Proposal Completion Date.

Dear Mr. Antonio Viegas,

We are writing this letter to change the Program Starting Date of your Round 8 tuberculosis grant.

In accordance with the Global Fund's policy, the Program Starting Date for the grant may be adjusted to align with the date the first disbursement was made to the Principal Recipient. The first disbursement under this Grant was made on 2 December 2009. As a result, the Program Starting Date for this Grant is adjusted to 1 December 2009.

This is also the starting date for the first reporting period set out in Performance Framework and Summary Budget for Years 1&2 in Annex A of the Grant Agreement.

The term of your grant remains two years and, if the grant is approved for a Phase 2 extension, five years. Therefore, we are also changing the Program Ending Date and Proposal Completion Date.

In addition, we are updating the name of the Global Fund Additional Representative in Block 13 of the face sheet of the Grant Agreement.
