## Announcements and overview of the process

Dave Abeleven: Mrs. Valerie Refos – Lalji (Ministry of Natural Resources) is sick and unable to attend.

Bryan Drakenstein: Nathalie Emanuels (MIA and NAP ASGM project coordinator) is unable to attend the meeting.

Armstrong Alexis: There were no written comments received regarding the Prodoc and other documentation which were sent via e-mail on the 1st of March 2018.

## Armstrong Alexis:

- introduced and gave an overview of the LPAC process and explained that within the UNDP, the approval of a project must be followed by a LPAC meeting. This meeting will be the last opportunity to review the project and to adjust the project documents prior to signing.
- The meeting will be held according to the LPAC guidance and templates available.
- The minutes from this meeting should be signed by the attendees.

## Presentation of the project

Dave Abeleven, PS Ministry of Natural Resources, indicates that he needs to leave at 09.15 for another meeting on cross border cooperation between Guyana and Suriname. The PS continued with the presentation of the project (see Annex 2):

## Key points from the presentation:

- This project is timely and linked to Suriname development plan (OP) 2017-2021, that has increased emphasis on environment friendly mining techniques as part of Suriname measures to adapt to Climate Change and build resilience as well as improve the quality of life of its population.
- The shifting of ASGM sector from informal to formal, illegal to legal, from environment unfriendly and unsustainable practices to Environment Friendly Mining practices.
- This project and associated total project budget was also mentioned by the Minister of Natural Resources during the Parliament deliberations on ratification of the Minamata Convention.
- As you know the law on ratification of the Minamata Convention was subsequently approved in Parliament. We are currently preparing the instruments for submission to the convention.
- Looks forward to next steps and subsequent signing of the project document with the UNDP.

### Remarks and discussion:

## **Armstrong Alexis:**

- Congratulated the government and parliament with ratification of the Minamata convention.
- Highlighted the importance of synchronization of our efforts with the Guianas due to the porosity of the borders.
- How can be dealt with knowledge versus actions because the small-scale goldminers are continuing to use mercury while aware of its harmful effects.
   The important question is: why are they still using mercury while being aware of its harmful effects?
- Unless the small-scale goldminers can be successfully transitioned from using mercury dependent - to non - mercury dependent machinery, increased knowledge will not enhance the effectiveness of the project.
- How can the small-scale goldminers be moved from the illegal sector to the legal sector and how they can contribute to the local income of the government (taxes)?

#### Dave Abeleven:

- The ministry of Natural resources wants to use this opportunity to move the small-scale miners from the illegal to the legal sector.
- A Suriname Guyana border counsel has been installed by the Presidents of Guyana and Suriname and the illegal import and transport of mercury between Suriname and Guyana has been put on the agenda for today's council meeting. Activities will be identified to reduce and eliminate the illegal import and trafficking of mercury.
- The policy of the Ministry of Natural Resources will also be updated: including New mining laws prohibiting the use of mercury will be put in place.
- There is support from the World Bank to aid with the restructuring of the Bauxite Institute, Geologic Mining Division into the Mineral Institute and the framework of the legislation. The assessment report will be shared when finalized. The ministry is considering in addition to an inter-ministerial committee working on the revision, to use expert support from a International or local consultant to expedite the process of updating the legislation. The ministry is looking for additional funding for this. Its is understood that policy and legislation alone will not bring an about face change, but it supports in realization of this change. With a potential of getting premium prize (green Gold) for Suriname gold.

#### **Laurens Gomes:**

- Also offered congratulations on the ratification of the Minamata convention.
- WWF Guyanas expects a decision from FFEM on status of her Co-financing on 23<sup>rd</sup> March 2018.
- Is there an option to improve the link between the Minamata trajectory and the results under the GEF Suriname FSP Goldmining project? Mercury reduction

targets (and funding) were omitted from the project design, however can we include results and report these under the project.

Armstrong Alexis: The ratification of the Minamata Convention was not put as a condition for approval of the project because the ratification was out of our control. Now that the convention has been ratified there are numerous opportunities for linking the Minamata convention implementation in Suriname with the project.

## Ruben Martoredjo:

- Prodoc: Page 364: What report is available on the social implications of the small-scale goldmining on the communities and surrounding areas and what about the means regarding social provisions?
- Bryan Drakenstein responded: The indigenous and tribal peoples have been consulted. The report is available and part of it is included in the project documents. There was an explicit mission to get consent from the tribal leaders from the communities along Compagnie kreek and at Nieuw Koffiekamp. Snesi Kondre is not a Village and does not have a Traditional leadership.
- Prodoc: page 23: "On the other hand, the project will work through recognized and trusted non-governmental organisations to put in place Mining and Training Extension Centres (MTECs), to ensure that there is no perceived bias". What is meant with recognized? and trusted by whom? The way it is formulated is ambiguous. It should be defined more clearly.
- Bryan Drakenstein; We will review and revise the text accordingly.

# A. Presentation of the Environmental and Social Screening Template

Armstrong Alexis: suggested adoption of the Environmental and Social Screening template since there are no comments and no comments were received when the template was sent by email on the 1<sup>st</sup> of March. The LPAC members agreed and adopted of the Environmental and Screening template.

#### Question 3:

Laurens Gomes: Have draft responsible party agreements been prepared for responsible parties?

Bryan Drakenstein: Responsible party agreements Not yet but will take place prior to start of project activities

#### Question 4:

A. Has implementation capacity of the proposed implementing partner been assessed?

Bryan Drakenstein: Medium because this has been partially done during design. HACT assessment to be done within UN context as well as substantial capacity assessment. Mitigation measure is that in interim only direct payment as part of HACT will be implemented.

I. Has the HACT micro-assessment been carried out? Is the method for cash transfers (i.e. advances, reimbursement, and direct payment) clearly specified?

Bryan Drakenstein: HACT has not been done for the new cycle. It will be done by end of the second quarter of this year.

Armstrong Alexis: Suggested adoption of the checklist.

The LPAC member were all in agreement and approved of checklist with the additional wording.

Armstrong Alexis: requested if the LPAC is in favor for the approval of this Prodoc with the recommendation for signature by the CO with the understanding that the comments as discussed will be incorporated in the project document.

The LPAC members are all in favor and approved of the project.
