The project furthermore also includes activities that promote the in-depth engagement with media and civil society organizations in order to receive their feedback on how they can effectively and responsibly engage in the 2020 elections. The outcome under the project that deals with “Enhancing institutional capacities on electoral conduct” has specifically been included to ensure that the Government machinery that deals with the organization and planning for elections is educated and able to safeguard the rights of citizens related to general elections while the second outcome “Education of citizens on their rights, procedures and processes regarding elections” aims to ensure that the citizens, who are the rights holders in this process know their rights and are able to claim these.

Under the project specific attention is paid to the participation of women as voters and the participation of women as candidates on the ballot. 
